Ms. Jessica Baraket stated that this was advertised on Public Purchase and was accessed by 64 vendors and Telco was the lowest bidder. The city has done business with them before.

Mr. Daryl Hendricks asked if there were any questions from his colleagues.

Mr. Ed Zucal asked how many intersections is that going to include.

Mr. Craig Messinger stated that this is actually for two blocks worth of lighting. This is pedestrian lighting for Turner Street, Chew Street. This is the next street going down to Court Street. This is for lighting and trees.

Ms. Cynthia Mota asked what are the two blocks.

Mr. Ed Zucal stated that he thought it was going to be for ADA curbs.

Mr. Julio Guridy stated that \$250,000 comes from CDC. He asked if it is the name only.

Mr. Craig Messinger stated that this was put forward for this project. This is for lighting projects. This is aesthetic projects.

Mr. Daryl Hendricks asked if there were any other questions from Council or the public.

Mr. Glenn Hunsicker asked was it a comparison done from the previous ADA.

Mr. Craig Messinger stated that this was competitively bid last year and it came in a couple \$100,000 more. They held off one year to see whether or not it would make a difference in pricing with some of the contractors. It is the same amount of work and cost less.

Mr. Glenn Hunsicker asked when will they start and when is the completion. He asked how many more contracts do you estimate to be done in the City of Allentown in the next couple of years.

Mr. Craig Messinger stated that they are meeting with the contractors. He stated that the city's plan is to do as many projects as they can. He stated that the city applied for grants. This is not just ADA, but also pedestrian lighting and trees. It is more of a beautification project. The city does ramps every year whether it is \$500,000 or \$1 million.

Mr. Glenn Hunsicker said when the city is doing these types of proposals, why can't we have a little show and tell on the screen.

Mr. Craig Messinger stated that they are looking to continue down 4th Street onward and come back and work out a way to the west side of 7th to 10th Streets. The pedestrian lighting on 7th Street was part of that plan.

Mr. Julio Guridy stated that it coincides with the Five Plan Capital Plan.

Mr. Daryl Hendricks stated if they can do similar to what they do for Street Vacations, provide photos and maps. He asked if there were any other questions from the public.
