Mayor Ray O'Connell stated that the administration will have a meeting with Mr. Armstrong and the Health and Human Services Department. Because of the Rally, it had to be rescheduled. They will have the meeting on November 17 at 2:00 PM. He will get back to Ms. Gerlach that had some questions and he will have information for her.

Controllers Report

Mr. Jeffrey Glazier stated that he has two Reports regarding the Golf Course. They did a cash count at the Golf Course on the 24th of September. The three major findings are: As noted in the budget presentation, the Golf Course is no longer taking cash. Everything is done by credit card. The Golf Course has petty cash on hand of \$500. Given that everything is done by credit card, they feel the amount is

excessive and their recommendation to the administration is significantly reduce the amount of petty cash available at the Golf Course. They have done a number of petty cash checks over past three or four weeks and that recommendation has been the same for every account they looked at. With the advent of P-Cards, petty cash is a thing of the past. Departments that may have had \$100 - \$150 really might only need \$50 or no money at all. They advised the administration to act on those recommendations and that the petty cash can be reduced at the Golf Course. The second finding: Reviewing the monthly reporting, the amount of the sales tax the city was paying on the Driving Range. The sale tax is computed already in the charge for \$1 a ball. The machine does not give change. The computation that the city was using to determine the liability was incorrect. The city was paying about six percent too much over the course of this year. It would amount to somewhere of \$1,000. The recommendation is that we do the calculations correctly. They should go back to the state to see if they can get the overages that they paid previously this year refunded and going forward that amount would be calculated correctly. They did not go back in prior years, but suspects they overpaid in prior years as well. The last finding, is gift cards. The Golf Course does a good business in gift cards, but when they were out there discussing the cash accounts it was noted that they have a significant amount of aging gift cards. They are well over five years old. They are advising the administration to consult with the Solicitor to see if these old gift cards fall under the state's escheat property laws. If they do, they will need to be turned over to the state. If they don't they will hang out. They know who the card owners are and can determine that, but there is something that they are counting on the Solicitor's office to weigh in on. The second audit, is regularly they will look at revenue contracts. Whether they are Towing Contracts or Residential Leases. They have an audit going on for cable franchises. He is speaking about tonight is Dan Frank Enterprises that is also doing business as Jack's Slice Pizza. There are couple of findings. Anyone that is doing business with the city needs to have insurance. It was determined that the certificate of insurance for Jack's Slice had expired on the 3rd of June 2020. The next certificate obtained after the initial request was dated August 31, 2020. Although the request was made by the administration, Jack Slice did not provide any proof to indicate that there was insurance coverage between June 30, 2020 and August 31, 2020. They recommend that Jack Slice is reminded of their obligation to abide by the term of the lease and the administration determines if it was a breach of lease agreement and seeks guidance from the Solicitor as how it should be handled. The administration responded, the city's Risk office requested information on the possible lapse in coverage identified in the audit report. The Lessee did not respond and Risk requested assistance from the Solicitor's office. The Solicitor's office received a response that goes as follow. The business partner received all the mail at his home. The business was shutdown during Covid. The insurance was lapsed and canceled. There were conversations with the administration regarding the insurance. The initial auditor's comments were as such: Jack Slice had a limited opening on June 23, 2020 and then opened up the

outside pavilion in early July. It is apparent that they operated for a significant amount of time putting the city in tremendous risk by operating without insurance. Other findings: late fees were waived by the Analyst that manage the account. He stated that the Controller's recommendation is that the Analyst does not have the authority to terms of the Lease Agreement. Changes to the Lease Agreement should be documented and properly approved. The administration agrees and in the future will ensure the Lease terms were adhere to and that any changes will be from the proper authorities and properly documented. He went over the Reporting Requirements. There is no evidence could be obtained that these Reports were received by anyone in the city. The Leasee should be reminded of their obligation and the administration should determine if there was a breach in the Lease Agreements.

Ms. Candida Affa asked if this is the first time this happened with the reporting. Mr. Jeffrey Glazier stated that he does not get the reports directly. He thinks that what they are often concerned with when they do a Revenue Receivable is to look to see if the money has been paid. This time they went a bit deeper.

Ms. Jessica Baraket stated that this was an older Contract and was not in the Eden Module. It is before they implemented the Insurance Tab in the Eden Module. That is something that they just started implementing in the last year. Where are tracking the insurances and the certificate of insurance within Eden along with the contract. It could have happened or could have not happened. Going forward they have a mechanism in place that they are able to identify when these contracts are expiring. They should be able to pick up on these things sooner and be able to address them.

Ms. Candida Affa asked if Ms. Baraket if this insurance was not implemented before.

Ms. Jessica Baraket stated not that it was not implemented. They were not tracking them in the Contract Module of the financial system in Eden. They just started implementing in 2020. They can now run a Report a couple months ahead of time. They are running them three month ahead of time of what insurance is running out and contact them before they are expired. They can start monitoring before they expire.

Ms. Candida Affa stated that is a dangerous situation especially to make sure they have liquor liability insurance. That is a separate insurance as opposed to the General Liability.

Ms. Jessica Baraket stated that all insurances are handled through the Risk Management Department. They have the appropriate insurance they have. They make sure to monitor what insurance are needed and making sure the city have the

proper insurance. The city just put the process in place to make sure that the insurance is tied to the contract within Eden. She stated that she will follow up with the Risk Management Department.

Mr. Ed Zucal asked Ms. Baraket if they are current on their insurance now.

Ms. Jessica Baraket stated that is correct.

Mayor Ray O'Connell asked if Mr. Messinger was there.

Mr. Craig Messinger stated that this was to apply for a PennDot Multi-Module. For a traffic signal at Highland and 15th Streets. Also, upgrading the intersection at Sumner Avenue and Roth Avenue to include the city's traffic adaptive system that will run on 15th Street from Elm Street north all the way to the city line. It is a safety enhancement project for Trexler Middle School at Greenleaf and 15th Streets which would have rapid flashers put in and the correct crosswalks and signage. This is a grant. The total project will be a little over a million and this will be \$830,000 that the city is requesting from PennDot to complete this project.

Mayor Ray O'Connell stated that if you ever drive at 15th and Highland during peak time, sometimes you can wait for 10 minutes until you get to the stop sign to get to 22. It is long overdue.

Mr. Daryl Hendricks stated that he travels that route often and it is extremely quick and very easy getting through. He has tried different routes, but living there for 10 years, there is no faster route to get through the city than 15th Street. It is amazing.

Mayor Ray O'Connell stated that if the lights are working. Sometimes they are not timed.

Mr. Daryl Hendricks stated that they are most of the time.

Mr. Craig Messinger stated that part of the Traffic Adaptive System does not mean just priority for a couple of cars at 15th when the traffic volume is low. A lot of that will help out pedestrians maybe at the intersection, but also the cross traffic. Regular signal timing will be the quickest, but the Traffic Adaptive really tries to take a look at what the needs are at that time and go with it. This will help the final leg of it.

Mr. Daryl Hendricks commended whoever removed the excess lineage between Tilghman and Gordon Streets.

Mr. Craig Messinger stated that the contractor did come in and they have a high pressure water spray system.
