Mr. Aziz Wehbey, Irving Street, stated that as a member of the Syrian American community. He would like to thank Mr. Guridy and all the members of City Council and the Mayor. On behalf of the Syrian American Community of Allentown he would like thanked Mr. Guridy and all the member of the city and the Mayor for their support for preparing the Proclamation recognizing the Syrian community. He is looking forward to a beautiful event on April 17 to show the beauty of Allentown. Nothing will ever divide the community of Allentown.

Mr. Julio Guridy stated that he would like to quickly address the Fairview Cemetery issue. He went and drove through the cemetery and it is something as it was explained before. There were a lot of people who did a lot great things for our city are buried there. He saw the stones falling and it looks deplorable. It looks really bad. He doesn't know what they as a city can do. It is up to us for the people that built this city that are buried there to rest in peace. He doesn't know what the city can do, but they should pay attention as a city. They should look into it to see if they can get some funding from somewhere and dedicate to make it better and decent and we can be proud of. It is a large cemetery. There are former Mayors buried there. One of his idols, General Trexler who did so much for them and provided the parks and funding of Trust to fund the parks and maintain them as well as community organizations and nonprofit organizations that are profiting so much from what he did for us and left for us. He asked the Mayor.

Mayor Ray O'Connell stated that he and Mr. Hendricks met with Mr. Fatzinger about a month ago and Mr. Fatzinger is doing an outstanding job over there. They will continue to work with Mr. Fatzinger to see what they can do, but they have to come to the realization that it is privately owned. Tyler is working hard. It is a fine line when you start committing funds to a privately owned organization. They are going to continue to work with Tyler. They are going to set up another meeting because he brought some thing up that they had to investigate.

Mr. Julio Guridy stated that he got the Mayor's point. It is private property. There are some private properties that we help. Things like the NIZ for example. That is a private property and a private institution. We help as a city to redevelop our downtown.

Mayor Ray O'Connell stated that is a stretch. He is sorry and not being disrespectful, but that is a stretch.

Mr. Julio Guridy stated that it may be a stretch in regards to what you are thinking, but it is not a stretch on how we can partner with private property. That is something with PPP is something that we should not overlook. It might be a possibility and advocacy. We can work with the Trexler Fund to provide some funds or other organizations. Even at the state level perhaps. He stated that he is not saying that they can take tax dollars and give it there. He is saying we can serve as a conduit to help. He thinks there is a way to do it, if they put their minds together and very want to do it.

Mr. Daryl Hendricks stated that it is not even a matter if money. It is a lack of cooperation between the owner of the cemetery and Mr. Fatzinger. He was allowing him to do it up to then. He stated that he grew up over there

and walk through that cemetery many times as a child on his way to Fountain Park swimming. He will be more than happy to be a liaison and meet with the owner of the cemetery and talk to him and see if he can get some cooperation.

Mayor Ray O'Connell stated that would have been our next step. They would get some more information.

Mr. Julio Guridy stated that he went over there for a burial and he met with the owner. The owner actually asked him how can the city help him. He stated that he is not sure where the communication is. He was very candid.

Mr. Daryl Hendricks stated that it is a breakdown in communication. Mr. Fatzinger is willing to work and use his own volunteers and do the work. He was not looking for us for money.

Mr. Julio Guridy stated well there you go. The person did not say or the owner did not say he wanted money from the city. He stated that how can we help.

Mr. Daryl Hendricks stated that he was offered the help, but there is some conflict there. He will see what he can do to resolve it.

Mr. Julio Guridy stated that if he could be part of that, he would love to be.

Mayor Ray O'Connell asked do you know who owns it.

Mr. Julio Guridy stated yes. He stated that he believes it is the one who owns the funeral home.

Mayor Ray O'Connell asked Mr. Guridy for his name.

Mr. Julio Guridy stated that he has to look for it.

Mayor Ray O'Connell stated Mr. Fatzinger is a great young guy. A hustler and doing the best for the City of Allentown.

Ms. Candida Affa asked to make a suggestion. They made the suggestion years ago and it is a shame they can't get the county because years ago the prisoners with work release used to and she in back of the cemetery back in the 80s. They had work release there. We tried years ago, but it is up to the county. All our cemeteries will be in good shape.

Mr. Joshua Siegel stated to the best of his knowledge it would be the prison itself. The Director of Corrections or someone specifically that

works the Work Release Program.

Ms. Candida Affa asked if it is the warden.

Mayor Ray O'Connell stated that they will start with Phill.

Mr. Joshua Siegel stated that they can start with Phill, but also the Director of Corrections.

Mr. Daryl Hendricks stated that he can't say for certain, but there are very few prisoners in there right now in the work release program.

Ms. Candida Affa stated all we need is 10.

Mr. Joshua Siegel stated that the Work Release Program is closed right now. It is shutdown. It is not even functioning right now. In the interest of Covid, they closed it. They are not even doing the Work Release Program at this point in time.

Mr. Julio Guridy asked if they can take this conversation offline so they can work on with the meeting. He stated that it is a good idea.

Ms. Candida Affa stated yes. It solves the problem.

Ms. Ce Ce Gerlach stated that she wants to respond to a different topic what the member of the public wrote in about. The tiny homes. There is so much conversation and passion about the tiny homes. Just to put everyone's fears aside. On the 24th, there is going to be a meeting at 6:30 PM and they will be discussing tiny homes. Oath can present their proposal. We as a community will look at it. As Council can look at it, offer feedback and ask questions. There is a proposal from Oath and then there is a concept. You can be for or against the proposal from Oath, but still support Tiny Homes conceptually. They need to have that conversation. During the Commission on the Homeless, they did not ask any questions. Right after that, they had a Public Hearing that needed to be started on time. They will be entertaining a discussion on the 24th about the plan that was presented tonight.

Mr. Joshua Siegel echoed the comments to the community. He is hoping that the public is aware and cognizant of the fact that they will have a meeting on the 24th. They are going to put a lot of work in and have a thoughtful discussion. Specifically to the Tiny Homes subject, there is a lot of passion and energy around the Tiny Homes subject that he is overjoyed. Tiny Homes is an integral part of addressing the issue of chronic homelessness here in the City of Allentown and the United States. There

are a number Tiny Homes models throughout the country that worked. They have worked remarkably well. There have been some push back as well. Some people may have seen some articles in the paper suggesting Tiny Homes themselves were not the route to go. He stated that Ce Ce is right. We can talk about Tiny Homes in abstract concept. There are no way of panacea to the issue of homelessness. It is obviously from the presentation you can see it is a multi-prong effort. He wants to make sure that the community knows that they are definitely going to do their due diligence and have a thoughtful discussion. Tiny Homes will inevitably have to be part of that solution. By no means the soul thrust of our efforts.

Mr. Julio Guridy thanked Mr. Siegel and Ms. Gerlach. He said at the beginning of the conversation that they will have a meeting and have a meeting on the 24th and people will be able to speak and ask questions. That is for a different meeting. What time is the meeting?

Mr. Michael Hanlon stated that it is a CD meeting.

Ms. Ce Ce Gerlach stated that it is at 6:30 PM.

Mr. Julio Guridy stated that we can talk about it at 6:30 PM on the 24th. We are definitely not avoiding the subject, but we have a meeting dedicated for that.

Ms. Candida Affa stated that if it is going to be a presentation at City Hall, isn't that an presentation at City Hall next Saturday.

Ms. Ce Ce Gerlach stated the exhibit of the homes.

Ms. Candida Affa stated that this will give us an opportunity to see what is going on.

Mr. Julio Guridy stated that it is an interesting concept that we have to look at.

Ms. Ce Ce Gerlach stated that we have to look at it.

Mayor Ray O'Connell stated that it is a demonstration this Saturday at noon right outside of City Hall. They are coming in from Washington State to put it up and see it.

Ms. Ce Ce Gerlach stated that this was forwarded favorably 2 - 0. It will
help us step up our game when it comes to communications in the city.

Mr. Julio Guridy asked if there were any comments from dais, the
administration, and the public.

Mr. Jeffrey Glazier stated that he spend a fair amount of time looking at this

bill. He agrees with the administration with a number of things with this. We certainly need additional help in Planning. It is exceptional wise for the administration to hire somebody to work on the metrics of social media so they can up their game there. He do however, have some concerns regarding the Visual Production Technician. Before we get there, there are two other concerns. These positions are in the FLSA status in terms of overtime. These positions are nonexempt that means they are eligible for overtime. However, in the programs they are putting in. A. there is no premium pay account. B. there is no money for a premium pay account. At the moment, he does not know how much overtime these people are going to use. There is oversight. That should be addressed before the bill is passed. Not after the bill is passed. He raised some exceptional valid points about Lights in the Parkway. The administration was less than happy that I did not give them a heads up. That I had some reservations. He had advised the mayor in advance that he had questions here. Additionally, he forwarded the questions to the head of the department that would hire these people and he had not had a response from that person. The questions went out on Monday, he would think it was more than an adequate time to get a response. He has zero. Both of these positions Visual Production Technician and the person who would handle the metrics for public media are nonexempt. They get paid overtime and there is no money to pay them overtime. He thinks that needs to be addressed before the bill is passed. With regards to the Visual Production Technician, this person is going to spend time with equipment. A lot of the time according to the job description about 240 percent of the time. You only can have 100 percent. How does the Controller come up to 240 percent. In the job description that was placed that you guys got and it was placed in Granicus, it lists the frequency of what job tasks are going to be done. Some of the jobs tasks are as required and others have a specific percentage there. If you add up the specific percentages, we are 240 percent. if you can get someone to give 240 percent, God bless you. The second thing in this job deception is duplication. Essential duty #9 is exactly the same of essential duty #11. This position has been rushed. The person that is going to handle the metrics, 25 percent of their time is to produce original content. He would think that this position can be put off for another year. We have no equipment. We have no money for equipment. It is not budgeted for any department. It may be some various throughout the year. We are not talking about a little flexibility. We are talking about \$1,000. It would be wise for anyone to come back to Council. It builds trust between the administration and Council. He sees no indication here. His reservation with the position is two-fold. The job description is not finalized. There is no equipment for this person to work with and there is nothing budgeted in the current budget. The other position will do a lot of work on the metrics. They are upping their game in public media. Twenty-five percent of their time is on original content that Council should certainly not

hire that position this year and/or the administration.

Mr. Julio Guridy thanked Mr. Glazier and stated that his point is very well taken. That is why you get paid the big bucks to advise Council of all these things. He will give the courtesy to the administration to see if they want to say anything.

Mayor Ray O'Connell asked Mr. Lightner if he wanted to say anything.

Mr. Leonard Lightner stated that he is there. To respond to Mr. Glazier's. He stated that Mr. Glazier sent it on Monday, but he was at a funeral. He did not have time to respond. As far as the positions being nonexempt with overtime, there has been plenty of time over the years that we did not have premium pay. If there is no premium pay, there is no overtime. Regardless if there is premium pay or not, that is what managers are for. We manage personnel and the process and the procedures. If there is no overtime there, there will not be overtime allotted for these individuals. Secondly, Mr. Glazier is the Controller. He is not the administration nor the eighth Councilmember. He should not be in administration business as we are developing positions. Now, for the job description itself. The job descriptions can always be modified. Mr. Glazier was not part of the survey or the job study when all the cabinet members were at the actually meeting when they were doing the job study and the consultants were doing the job study. There are possibilities and times when you can go over the percentage. Now there are daily percentages and weekly percentages and monthly percentages. Now, the job description itself was not rushed. This is a new position and they will have to modify as they go along. Of course, there is no money in the equipment budget because this position was not planned at last year's budget. He will not transfer money into the Equipment Fund right now until the position is approved. If you approve the position, then we will take the next steps putting money into the Equipment Fund. We will come to you asking to put money into the Equipment Fund then be questioned of why we are putting money into the Equipment Fund to purchase items for a position that doesn't exist. Yes, we do need to do things in steps and stages. First and foremost is to get the approval from you all and say yes we can do this position. He stated that he will take the next step to tackle that issue as far as equipment goes. He stated that Mr. Glazier is far past what his job duties are.

Mr. Julio Guridy stated that they are getting to personal attacks and he does not think they should get into that.

Mr. Leonard Lightner stated exactly. We should not have to do this in the public.

Mr. Julio Guridy stated that they should not get into that.

Mayor Ray O'Connell stated that he did it three weeks ago.

Mr. Julio Guridy stated that it does not matter. It was wrong. Two wrongs do not make it right. Let's get back on the board as civilized as we are and work through this. He stated that he is not going to allow this back and forth in his Chambers.

Mr. Leonard Lightner stated that he is not going to attack, but to be civilized his points are overtime itself. We put rules and blocks on overtime. If there is no premium pay, there will not be any overtime allotted. These are new positions and as new positions they have to get on the ground and get acclimated so it would not be any overtime in the first year. Now, as far as the percentage goes in the job description, don't deigrate our process. We put the job description in and it can be modified and will be modified. We never had to go to Council before to change a job description. That is up to the administration as time goes we will adjust it. He stated that these two position go hand and hand. If you decide not to do it, that is fine.

Mr. Julio Guridy thanked Mr. Lightner and for understanding his position on attacking each other.

Mr. Leonard Lightner apologized for taking it personal. He did not mean to disrupt the Chambers.

Mr. Julio Guridy stated that he does not want to get into this big discussion because of lack of information. He is going to send it back to Ms. Gerlach's committee and probably get a Plan of what Mr. Lightner said. If you need to talk to Mr. Glazier come back with something that will go through appropriately.

Mayor Ray O'Connell objected to that. You had a committee meeting and it passed 2 -0. We did this three weeks ago. People should be at the committee meeting to hash it all out at the committee meeting before it gets here. At this point, sending it back and forth back and forth. Vote on it. Vote it up or vote it down.

Mr. Julio Guridy stated that he will send it back to Ms. Gerlach and bring it back. He stated that he does not want to go back and forth blaming each other. He stated that he does not think the city is going to close if they wait another week. Bring it back and get it right.

Mayor Ray O'Connell objected to it and stated that he wants them to vote

on it tonight.

Mr. Leonard Lightner asked if the entire Bill back. He asked about the Assistant Planner.

Mr. Julio Guridy stated that there were no issues with those.

Mr. Leonard Lightner asked if they can make an amendment to this Bill and pass these two and send the Visual back.

Ms. Candida Affa stated that she thought the question was for all three of these.

Mr. Julio Guridy asked if there were any comments from the dais or the administration.

Mr. Seth O'Neill stated that the Act 32 of 2008 requires a Tax Officer to collect all Earned Income Taxes within the tax collection district which is coterminous with the County of Lehigh. The Tax Claim Committee chose Berkheimer and Associates to do that collection for the entire and all the taxing authorities that levy Earned Income Taxes: School District and Municipalities within the county. The law that enables the local tax has a very strict confidentiality policy so when Berkheimer is collecting these taxes and sharing information with the municipalities, the tax and jurisdiction within the municipalities want to make sure that they have shielded themselves from any potential improper disclosure of improper confidential information so for that reason they make sure that there is a very select amount of people that can have access to the confidential information. Because there has been a lot of position changes in the Finance Department they requested this. He stated that they offered this to make sure that confidential information is not being disclosed about our taxpayers.

Mr. Julio Guridy asked if it was vetted through the Solicitor's office.

Mr. Seth O'Neill stated that he was not aware that it was. It is pretty standard. For example, when Mr. Hartzell was the Director of Finance he would have been the lead liaison. When people change positions, Berkheimer does not want to concede that anyone in a particular position can be the Custodian of confidential information. He is not sure if it was forwarded to the Law Office, but he is sure that Mr. Kloiber can speak to that if he has any concerns.

Mr. Michael Hanlon stated that this has been standard practice whenever it is change in leadership.

Mr. Julio Guridy stated that it is nothing to take to the Solicitor's office. This is the first time he heard this. He doesn't remember seeing a Resolution like this before.

Ms. Fran Fruhwirth stated that this Resolution and perhaps Mr. O'Neill can address it. Is This Resolution of City Council directing to affected that City

Council is directing the appointment of a liaison to Berkheimer or is the administration or the Finance Department going to select the people that are privy to the confidential information.

Mr. Seth O'Neill stated that his understanding is that this is a request that Berkheimer is requesting of passage of the Resolution by the governing body specifying that the confidential information that is needed for confidential purposes is exalting Berkheimer of liability with the connection with the release of the said confidential information and it specifies the people that it will release it to and then they are by this they are directed to provide the tax information. We need this and access to this information on a regular basis. The statute is very much in favor of abundance of confidentiality it is not super specific. Berkheimer is requesting this so they can feel comfortable legally in sharing this information. The city, the administration is interested in their ability to receive this information. It does those two things.

Mr. Julio Guridy asked who are we sharing the information with. He does not understand what it says.

Mr. Seth O'Neill stated that what happens is when the taxing authority requires by ordinance under the Local Tax Enabling Act for taxpayers, employers or people that are obligated to report or pay taxes to the city under the Local Tax Enabling Act, they provide tax information: wage amounts, withholding amounts, financial information is provided to the tax collector. The tax officer is Berkheimer, for Berkheimer to share that information with the members of the administration that need to work with that information in the Finance Department. He stated himself, Jessica , Tricia Dickert, Bina Patel, Treasury and for NIZ certification Audrey Danek, one of our Financial Analyst. They need to share that information from them. They are the first line that collect it. They need to share it with us. It is being kept confidential.

Mr. Julio Guridy stated that is what he wanted to find out. Just to find out. They collect the taxes. They share the information with the Finance Department here who deals with the Tax Collection.

Mr. Seth O'Neill stated that they are making sure on their end that everyone is aware of the confidentiality clause is in effect. That is the one part. The second part is that they are authorized to release it to a certain number of individuals and to no other people.

Mr. Julio Guridy stated that the certain number of individual people are people that work in the city. Not necessary people out there.

Mr. Seth O'Neill stated in the Finance Department only.

Mr. Julio Guridy stated that he does not want his tax information to go around the world.
