As noted in the Zoning Ordinance of the City of Allentown. Section 1314.02.C.4 (7) there is a prohibition on permitting the Commercial Use in Residential districts if the use includes the on-site frying of foods. Bill No. 31-201 repeals this prohibition. The West Civic Association is opposed to this change on several fronts:<ol>

<li>We feel the current law is appropriate and should continue to be enforced.</li>

<li>The use of fryers in residential areas presents fire safety issues given the dense population and building structures in these neighborhoods.</li>

<li>The externalities associated with frying of foods in close proximity to residences put an undue quality of life burden on residents who are already struggling with multiple quality of life issues in the city.</li>

<li>Disposal of used cooking oil will potentially add to issues of waste disposal in the city. We also question how the city will be able to ensure that such waste is disposed of properly, or ideally recycled.</li>

<li>Providing increased access to and encouraging the consumption of fried foods is in direct contradiction to the policies being promoted in the city to improve the health of the city's residents. The Health Department is promoting exercise and access to fresh foods as two examples of investment in the health of the city's residents. Why would we use our zoning laws to contradict these actions?</li>

<li>It should also be noted that there is an increasing discussion of how cities can in fact use zoning to promote the health of their residents. We would be happy to share our research in this area with Council and other interested parties.</li>

</ol>We respectfully request that City Council, at a minimum, undertake additional analysis of the potential impact such a zoning change would have on the residents of the City of Allentown and also engage with the Health Department to discuss more positive ways we could increase access to healthy foods, such as increasing the availability of fresh produce and non-processed foods to residents. We would also suggest that Council provide evidence that there is sufficient resources to ensure that if such a change in zoning was permitted, the compliance with appropriate laws as far as the installation of equipment to ensure no negative impacts

with respect to quality of life or fire risk are followed. We would also request that the city respond as to how the waste generated will be dealt with. Will the city support a waste collection operation that recycles used cooking oil as is done in other cities? Finally, we respectfully request that a financial impact analysis of such a change in zoning be undertaken to ensure that the residents of the city are not burdened with further costs to administer and enforce this change in the zoning ordinance. **Controllers Report**

Mr. Jeffrey Glazier stated that he has an Accounts Payable Weekly Check Review Report from the 3rd of April until 30th of April. At the next meeting he will give a P-Card Report as well as a Bank Reconciliation Report or two. He went over the Accounts Payable Weekly Check Review Report.

Mr. Julio Guridy stated it was \$450,000 that was not approved by the Budgetary Process.

Mr. Jeffrey Glazier stated that the development where LANTA is, LANTA and the Parking Authority determined that they needed a property. Council duly recognized

the city would be the lead agency on this taking under Resolution 61 that was approved last June. The Resolution stated that the APA would set aside monies for this. However, he has not been able to find an MOU or a Contract approval of the city and APA. The city is handling the eminent domain and as part of that process, the city needed to put money in escrow to show its good will. It is unusual to cut a check out of a revenue account. The only time it is building permits that the city has to remit to the state. The perimeters of the expense was not identified in that Resolution. The city has not taken a property by eminent domain in quite some time.

Mr. Julio Guridy stated that is a lot of money to be spent and not notify Council.

Mr. Jeffery Glazier stated that Council was kind of were and kind of not. The Resolution did not specify the dollar amount and Council approved it last June. It said that APA would set aside the money. They only voted for it last week which was a week and a half when they had to pay the court. He is concerned about the accounting.

Mayor Ray O'Connell asked if the city received the check from APA.

Mr. Jeffrey Glazier stated that yes, but a week and a half after they had to put the money in. The money is listed as a contribution. He doesn't understand why it did not say it was a reimbursement.

Mr. Leonard Lightner stated that the account where the \$450,000 came out of is the account the city used for years. It is the Rental Rehab Account. It may be labeled incorrectly, but those are funds that come back from when the city loaned out money. These are HUD dollars. They are unrestricted funds. If they have to change the process then a conversation needs to be had with him.

Mr. Julio Guridy asked if the city took the properties by eminent domain, but they were occupied properties.

Mr. Leonard Lightner stated that is correct. Every person there has been relocated and their rent has been covered for the year. With the \$450,000, the city was paid \$500,000 because they don't know the owner is disputing the value. The city deposited \$450,000 to the courts for escrow.
