- **3. BUY** \$1,700,000 (one million seven hundred thousand dollars) of Vanguard Total Stock Market Index (VITSX; 922908801).
- **4. BUY** \$1,000,000 (one million dollars) of MFS Int'l Intrinsic Value Equity (MINJX; 552746349).

- BUY \$725,000 (seven hundred twenty-five thousand dollars) of MFS Int'l Intrinsic Value Equity (MINJX; 552746349).
