Dear Michael Hanlon:

The Department of Environmental Protection (DEP) has reviewed the above referenced proposed Official Plan revision.

This project proposes the redevelopment of a 17.5 acre parcel creating an industrial warehouse consisting of two (2) buildings located at 606 South 10th Street in the City of Allentown, Lehigh County. The project will connect to the City of Allentown Collection System located on South Tenth Street. The project will generate 3,570 GPD (15 EDUs @ 238 GPD per EDU) of sewage flow to be treated at the Kline's Island Wastewater Treatment Facility. Potable water will be provided by a public water supply.

The plan revision is approved.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:
