AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for a transfer of Nine Thousand Five Hundred Dollars (\$9,500.00) from WPA Capital Project into the Franklin Park Capital Project. These funds will be utilized for the creation of a concept plan for Franklin Park as part of a grant application.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the amount of Nine Thousand Five Hundred Dollars (\$9,500.00) from the WPA Capital Project account to the Franklin Park Capital Project account in the following manner:

SECTION TWO: That this Ordinance takes effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
