AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for a transfer of Seven Hundred Thousand Dollars (\$700,000.00) from the Residential Street Construction capital account to the City-Owned Building Repairs capital account. This will transfer the unused funds from the Residential Street Construction project to the City-Owned Building Repairs capital account.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of Seven Hundred Thousand (\$700,000.00) as follows:

Public Works – Building Maintenance

- Summary and facts of the bill.
This bill is to transfer funds from the Residential Street Construction capital account (1748) to the City-Owned Building repairs capital account (2041).

Due to the Utility Cost Share Program, a Residential Street Construction program has not been needed due to our paving program through UGI and LCA. This funding will be used to do repairs on city owned properties such as Bridge Works, Fire Houses, and City Hall to include replacing the sawtooth portion of the roof at Bridgeworks and replace the Boiler at City Hall. The roof at Bridgeworks is actively leaking and in need of serious repair. The Boiler at City Hall is beyond its life and needs to be replaced as soon as possible.

The purpose of this bill is to transfer funds from the Residential Street Construction capital account to the City-Owned Building Repairs capital account. The funds are needed to make necessary repairs on City owned buildings.
