Authorization for Contract with Alloy5, LLC, a small business, in the amount of \$50,000.00 to provide professional services to facilitate the relocation of the City's Police operation to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Police force to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). Lastly, alternative proposal services include the conceptual design of the needed improvements upon authorization by the City after a decision has been made as a result of the initial services.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

- 1. Name of Contractor/Consultant: Alloy5, LLC
- 2. Project or Contract Reference: RFP No. 2023-17 Feasibility Study for APD
- 3. Description of Service(s): To provide professional services to facilitate the relocation of the City's Police operation to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Police force to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). Description of project or scope of services to be provided:

On March 22, 2023, the City advertised a solicitation for a qualified team to provide professional services to facilitate the relocation of the City's Police operation to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Police force to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). Lastly, alternative proposal services include the conceptual design of the needed improvements upon authorization by the City after a decision has been made as a result of the initial services. On April, 12, 2023 the public opening was held for which the City received six (6) proposals but one (1) proposal was rejected. Therefore, five (5) proposals were distributed to all committee members via Teams for evaluation. The technical evaluation was held on April 27, 2023. All committee members were present in person. The Proposals were scored based on the RFP requirements, IBE Preference (10 Points), Scope of Work (40 Points), Statement of Qualifications (30 Points) and References and Other Information (10 Points). Cost proposals were opened on April 27, 2023. Proposals were distributed to all committee members via Teams for evaluation after the completion of the technical evaluation. The cost evaluation committee meeting occurred on May 2, 2023. All scoring committee members were present in person. The committee members discussed the Cost proposal (20 Points). The Committee made the recommendation to not proceed with Oral interviews/presentations as they felt confident in deciding with the information provided in the Technical and Cost Proposals. The committee decided to award to the highest scoring firm based on the final score from the Technical and Cost Proposals. The committee is recommending award to Alloy5 LLC.

Contract Term:

The contract term shall commence upon full execution and shall cease one (1) year thereafter.
