AN ORDINANCE

Amending the 2023 General Fund Budget to provide for a supplemental appropriation of Fifty-One Thousand Six Hundred and Eighty-Eight Dollars and Eighty Cents (\$51,688.80) from PPL for the completion of Phase 2, 3, and 4 of the LED street light conversion.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation of Fifty-One Thousand Six Hundred and Eighty-Eight Dollars and Eighty Cents (\$51,688.80) to the following account:

Public Works – Traffic Planning

- Summary and facts of the bill.

The City received a one-time PPL rebate check for \$51,688.80 for completing Phase 2, 3, and 4 of the LED street light conversion. The LED Street light conversion for Phase 2, 3, and 4 was completed in the South Side, East Side, and Center City from 2018-2021. This funding will be used to complete the school zone flasher and Rapid Rectangular flashing beacon (RRFB) at 4th and Martin Luther King Jr Dr.

This project was mainly funded through a Transportation Alternative Set-Aside (TASA) grant initially awarded to the City in January 2022. The construction of this project came in over budget due to inflation, so this additional funding will allow the project to be completed.

This bill is to accept the PPL rebate check in the amount of \$51,688.80 and be placed in the Capital Account (1852) for School/Pedestrian Safety Improvements.
