# Introduced by the Administration on March 15, 2023

Authorization for Contract with Kulik Strategic Advisers in the amount of \$178,400.00 to provide a community health needs assessment and a community health improvement plan. The United States Centers for Disease Control and Prevention (CDC) establishes the public health activities that all communities should undertake to protect and promote the health of all people in the "10 Essential Public Health Services (EPHS)." These activities begin with the process of assessment; in order to know how health can be improved, a jurisdiction must first understand its needs, strengths, and assets. Therefore, community health needs assessment and a community health improvement plan is a key function of health departments, multiple bidders.

## Description of project or scope of services to be provided:

On December 13, 2022, the City advertised a solicitation for Community Health Needs Assessment-Community Health Improvement Plan, seeking a most qualified contractor to provide a community health assessment and a community health improvement plan. The United States Centers for Disease Control and Prevention (CDC) establishes the public health activities that all communities should undertake to protect and promote the health of all people in the "10 Essential Public Health Services (EPHS)." These activities begin with the process of assessment; in order to know how health can be improved, a jurisdiction must first understand its needs, strengths, and assets. Therefore, community health assessment and a community health improvement plan is a key function of health departments. On January 10, 2023 the public opening was held for which the City received nine (9) proposals and were distributed to all committee members via TEAMS for evaluation. The technical evaluation was held on February 1, 2023. All committee members were present via Teams. The Proposals were scored based on the RFP requirements, IBE Preference (10 Points), Ability to Meet RFP Requirements (20 Points), Firm's Experience (20 Points), Project Plan (20 Points), and References (20 Points). Cost proposals were opened on February 1, 2023. Proposals were distributed to all committee members via Teams for evaluation after the completion of the technical evaluation. The cost evaluation committee meeting occurred on February 6, 2023. All scoring committee members were present via Teams. The committee members discussed the cost proposals. After discussion the committee members scored the Proposals based on Cost (20 Points). The Committee made the recommendation to proceed with Oral interviews with the top three rating firms, 35th Street Consulting, Kulik Strategic Advisers, Inc and Strategy Solutions Inc. The Committee did not feel it necessary to interview the other firms. The oral interview meetings occurred on February 20, 2023. 35th Street Consulting presented at 11:00 AM, Kulik Strategic Advisers presented at 12:00 PM, and Strategy Solutions, Inc presented at 2:00 PM. Not all scoring committee members could attend the meeting, so their scores were removed. After discussion the committee members scored the oral interview (15 Points). The Committee made the recommendation to award to the highest scoring firm. The committee decided to award based on the firm's qualifications and overall score. The committee is recommending award to Kulik Strategic Advisers, Inc.

### Contract Term:

The Contract term shall commence upon full execution and shall cease 18 months thereafter.
