AN ORDINANCE

Amending the 2025 Grants Fund to provide for a supplemental appropriation of One Million Dollars (\$1,000,000.00) from the State Office of the Budget, Redevelopment Assistance Capital Program (RACP). These funds are a pass-through grant that will support Cedar Crest College.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the Grant Fund in the amount of One Million Dollars (\$1,000,000.00) from the State Office of the Budget as follows:

Legislative Template

- **What department or bureau is this bill originating from? Where did the initiative for the bill originate?**

Department of Community and Economic Development. This Bill is the result of the successful application and award of the Redevelopment Assistance Capital Program (RACP) grant for Cedar Crest College Athletic Expansion, located in Allentown, PA.

- **Summary and facts of the bill.**

Cedar Crest College submitted a formal application to the State Office of the Budget, for which the City will serve as the Grantee. The \$1,000,000 awarded in RACP funds will be used to improve the uses of the college's athletic fields.

 - a. **What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?**

This Bill distributes funds as specified within the RACP grant application and award regulations.

- b. **What are the benefits of doing this? What are the drawbacks?**

The Cedar Crest College athletic fields serve forty percent of the school's student body participating in NCAA Division III sports, allows the college to recruit student-athletes to the Lehigh Valley, and serves a variety of community groups using the fields for camps, clinics and sporting events.

- c. **How does this bill relate to the City's vision/mission/priorities?**

This Bill supports the multi-purpose use of athletic fields at a city college that hosts sports teams and events from the Northeast Region of PA, which in turn stimulates tourism and the economy in the City of Allentown.

 - a. **Cost (initial and ongoing)**

This is a PA Office of the Budget funded project, and all costs are covered by this grant. The total grant award is One Million Dollars (\$1,000,000.00) to be allocated to the Grant Fund. All grant revenue will be appropriated to 005-00-0000-0000-46213 Grant Fund, RACP Grants. The expenses will be appropriated to the Grant Fund, 005-01-5201-0078-50048.

The project benefits students and residents of Allentown as well as it brings additional revenue to the city through tourism.
