- Deal with very confrontational situations to begin building a working relationship with a family to reach a common goal of ensuring child safety.
 - Assist and mentor coworkers in the unit to engage with their assigned families.
 - Provide testimony at Juvenile Court proceedings.
 - Assigned as a mentor to new workers that join the agency.

- Provide a high level of supervision to undergraduate interns in completion of their field placement and child welfare experience.
- Facilitate support groups for both children and kinship caregivers
- Complete detailed home study evaluations on kinship caregivers in order to approve kin homes for children removed from their parents' care.
- Provide ongoing support to family, caregivers, parents, and children involved with Public Child Welfare
- Trauma Informed Care training completed and part of agency work group to implement trauma informed care
- Implement Child Preparation Services for children removed from their parents' care

2015-Present Supervisor

- Completed Pennsylvania Department of Public Welfare Child Welfare Supervisor Training Program
- Supervise Permanency Unit who handles all adoption cases and youth ages 16-21 in out of home placements
- Strengthen partnership with Lehigh County Juvenile Probation for crossover youth to be served in a team approach by probation and children and youth caseworker
- Support casework staff in completing a minimum of 12 court hearings each month
- Support casework staff in finalizing adoptions, a minimum of 24 children adopted each year
- Participate in community outreach in partnership with Valley Youth House, Lehigh Valley Permanency Project, Allentown Youth Housing Stability Project, Statewide Adoption Network, and National Adoption Awareness Month for Lehigh County
- Chair of Human Trafficking Subcommittee to develop screening tools and standard operating procedure for children that are high risk or confirmed to be involved with Human Trafficking
- Facilitate quarterly youth focus groups at Lehigh County
- Facilitate team building activities for the Permanency Unit to promote team cohesion
- Provide ongoing supervision both in scheduled and unscheduled forums for the unit members
- Assist in home visits, court hearings, and meetings to both provide support in high risk situations but also to cover the matter if schedule prohibits assigned staff to attend
- Contact and coordinator for youth age 18-21 who wish to reenter care
- Log ongoing statistics for adoption finalizations, children changing foster homes, exiting foster care, graduating high school, and monthly visits
- Complete performance evaluations and promote opportunities for the Permanency Unit to experience professional growth
- Perform after hour on call duties
- Minimum of 20 hours of training completed annually that focus on topics of child development, impact of drugs and alcohol, adoption, parenting, trauma, human trafficking and effects of child abuse and neglect.
