The purpose of the ordinance is to amend the 2025 General Fund Budget to provide a supplemental appropriation of One Hundred Eighty-two thousand \$ 182,000 from Commonwealth of PA Economic Development & Community Development Initiatives Program to the City of Allentown Police Department to utilize the funding for replacement of Police Academy range tower.

- Purpose.

- a. What does the bill do?

This is an allocation of \$182,000 from Commonwealth of PA Economic Development & Community Development Initiatives Program to the City of Allentown Police Department to utilize the funding for replacement of Police Academy range tower.

- b. What are the benefits of doing this?

The benefits is the replacement of the police academy range tower which is in the state of disrepair and of no current use.

- c. How does this bill relate to the City's vision/mission/priorities?

The new building would provide a secure space for range equipment and supplies for the police academy as well as facilitating the distribution and management of equipment and supplies while the range is in use. It would have an indoor space in which classes would be held and a multi-purpose patio area.

The grant is for the year 2025 in the amount of \$182,000 based on expected expenses for demolition, removal of debris and construction of new building.
