AN ORDINANCE

Amending the 2025 Capital Fund Budget to provide for a supplemental appropriation of Seven Thousand Six Hundred Twenty-Four Dollars and Ninety-Five Cents (\$7,624.95). This was the result of payment in lieu of tree plantings from Anthony P. Aspromonte, U-Haul of Pennsylvania, Lee Goldstein, and Antoun Zayat. Funds will be used for the purchase of new street trees.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 Capital Fund in the amount of Seven Thousand Six Hundred Twenty-Four Dollars and Ninety-Five Cents (\$7,624.95). Reflecting receipt of monies for payments in lieu of tree plantings.
