Authorization for Contract with Davey Resource Group, Inc. in the amount of \$220,000.00 to develop a comprehensive Tree Inventory, Species Master Plan and Urban Forestry Master Plan that is rooted in environmental justice and equity. Two (2) proposals were received, contract shall be for twelve (12) months with one (1) additional six (6) month renewal beyond the contract expiration period.

**WHEREAS**, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS,** it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

Description of project or scope of services to be provided:

On September 26, 2024, the City advertised a solicitation seeking a qualified consultant team to develop a comprehensive Tree Inventory, Species Master Plan and Urban Forestry Master Plan that is rooted in environmental justice and equity. On October 31, 2024, there was a public opening, for which two (2) proposals were received, which were distributed to all committee members via Teams for evaluation. The Technical evaluation was held on November 14, 2024, all committee members were present. The proposals were scored based on the following: IBE Preference (10 POINTS), Ability to Meet RFP Requirements (30 POINTS), and Prior

Experience/Team Member Qualifications (30 POINTS). The Cost Proposals were opened on November 14, 2024, and distributed to all committee members via Teams for evaluation after the Technical evaluation. The Cost evaluation was held on November 25, 2024, all committee members were present. The committee discussed the Cost proposals (40 Points). The committee decided to not move forward with and Oral presentations. The committee is recommending award to Davey Resource Group, Inc.

The Contract term shall commence upon full execution and shall cease twelve (12) months thereafter.
