Authorization for Contract with Traffic Planning And Design, Inc. in the amount of \$187,114.83 to provide supplementary construction inspection staff of one (1) Full-Time Transportation Construction Inspector (TCI)/Transportation Construction Manager (TCM) OR one (1) Part-Time TCI Inspector and one (1) Part-Time TCM Consultant with all certifications required for construction management, inspection, and documentation services on a PennDOT roadway. Two (2) proposals were received. Contract shall cease December 31, 2026, and may be extended for up to an additional twelve (12) months beyond the contract expiration period.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

- 2. Project or Contract Reference: RFP No. 2025-46 7th St. & Hamilton St. Realignment Project: Inspection and Management Services
- 3. Description of Service(s): To provide supplementary construction inspection staff of one (1) Full-Time Transportation Construction Inspector (TCI) / Transportation Construction Manager (TCM) OR one (1) Part-Time TCI Inspector and one (1) Part-Time TCM Consultant with all certifications required for construction management, inspection, and documentation services on a PennDOT roadway. The project consists of improvements at the following locations: (1) Improvements of the intersection of 7th St and Linden St which include curb, sidewalk, ADA Ramp, paving, pavement markings, traffic lighting, and signage. (2) Improvements of the intersection of 7th St and Hamilton St which include curb, sidewalk, ADA Ramp, Paving, pavement markings, pedestrian lighting and traffic lighting, and signage.

Description of project or scope of services to be provided:

On October 6, 2025, the City advertised a solicitation for a qualified engineering firm to provide supplementary construction inspection staff of one (1) Full-Time Transportation Construction Inspector (TCI) / Transportation Construction Manager (TCM) OR one (1) Part-Time TCI Inspector and one (1) Part-Time TCM Consultant with all certifications required for construction

management, inspection, and documentation services on a PennDOT roadway. The project consists of improvements at the following locations: (1) Improvements of the intersection of 7th St and Linden St which include curb, sidewalk, ADA Ramp, paving, pavement markings, traffic lighting, and signage. (2) Improvements of the intersection of 7th St and Hamilton St which include curb, sidewalk, ADA Ramp, Paving, pavement markings, pedestrian lighting and traffic lighting, and signage. On November 3, 2025, a public opening was held, for which two (2) proposals were received. The proposals were distributed to all committee members via Teams for evaluation. The Technical evaluation was held on November 12, 2025, all committee members were present. The proposals were scored based on the following: IBE Preference (10 Points), Ability to Meet RFP Requirements (40 Points), Firm's Experience (20 Points), and References (10 Points). The Cost Proposals were opened on November 3, 2025, and distributed to all committee members via Teams for evaluation after the Technical evaluation. The Cost evaluation was held on November 19, 2025, all committee members were present. The committee discussed the Cost proposal (30 Points). The committee decided not to hold oral interviews for this project. They have decided based on the Technical and Cost Proposal scores. The committee is recommending award to Traffic Panning and Design, Inc.

Contract Term:

The Contract term shall commence upon full execution and shall cease December 31, 2026.

Upon written agreement from the City, this contract may be extended for up to an additional twelve (12) months beyond the contract expiration period at the same annual terms of the initial term.
