AN ORDINANCE

Amending the 2024 General Fund Budget to provide for a supplemental appropriation of Fifty Thousand (\$50,000.00) Dollars from Rockefeller Philanthropy Advisors to support the creation of the Youth Climate Action Fund.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2024 General Fund in the amount of Fifty Thousand (\$50,000.00) Dollars from Rockefeller Philanthropy Advisors. Dollars as follows:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

This Bill seeks to accept a grant of \$50,000 from Rockefeller Philanthropy Advisors for the Youth Climate Action Fund to administer mini-grants in the amount of \$1,000 - \$5,000 to youth and youth-serving organizations for projects aimed at supporting the design and implementation climate education and impact campaigns.

The Bill appropriates the grant funds, which will support the creation of the Youth Climate Action Fund.

The development of the Youth Climate Action Fund can empower Allentown's youth to tackle urgent environmental challenges creatively and foster community engagement in climate action.

This initiative aligns with the City's vision by empowering youth to address urgent climate challenges and setting a framework to forge and strengthen partnerships for youth and youth-serving organizations that can be leveraged for the development of a climate action plan.

## Rockefeller Philanthropy Advisors

The grant term runs from April 1, 2024, to December 31, 2024. Mini grants must be released to subgrantees no later than September 2024 and projects completed no later than December 31, 2024.

- Why should Council unanimously support this bill?

The Parks and Recreation Department is finding new and creative projects to ensure a greener and more resilient future for Allentown. Approving this allocation of funds will allow the Department to foster new connections with youth and youth-serving organizations and empower youth to drive and implement projects that bring awareness of climate issues and sustainable practices.
