Dr. Cynthia Mota stated please observe the Rules of Council when given privilege of the floor. A copy of Council Rules can be found on the council agenda on the website; copies are also on the back desk along with the agenda. When anyone has privilege of the floor, I will not entertain personal insults, attacks, name calling or other behavior that is inconsistent with the purpose of conducting official business. If you would like to speak, we are asking that you fill out a card – they are on the back table provide them to the clerk before speaking. Include your name and address. Courtesy of the Floor is meant to provide public comment on items that are not on the agenda. Public comment during consideration of ordinances, resolutions and motions is limited by topic – your comments must be relevant to the subject matter of the proposed legislation. Public comments are taken before council votes on items. You are given privilege of the floor to provide public comment, it is not a question-and-answer session. If you are speaking on behalf of yourself, you have three minutes and if you are speaking on behalf of a group that has several members present, you will be given five minutes. Please address the Council President not individual councilpersons or city staff. Refrain from insulting or defaming staff, officials, and the public; refrain from using offensive language, cursing, and making noises while other people are speaking. Please be aware that comments and/or behavior in violation of these rules will result in a forfeiture of all remaining time and you will be asked to return to your seat. Also, Courtesy of the Floor we have to remember to remove our hats.

Mr. Pas Simpson, 215 N. Ninth Street, recently we have seen an uptick and a disturbance in our city. He stated that he won't victimize the victim again because she asked for them not to ask for certain things. They do want to make sure, they point out that there is a culture somehow of discrimination that is plaguing our city. It has gotten to be so bold that it has really just plagued City Hall. Not, just in these meetings that we have arguments back and forth over policy, but to the point it has affected someone's personal safety. This city has a responsibly to provide safety for its citizens to not just give language about DEI (Diversity, Equity and Inclusion), but to truly include its citizens. You cannot spell community without unity. He stated that they have done very well of dividing each other, pointing fingers, and finding reasons to be more and more hateful. He stated that our city needs to heal. It starts with this administration and each and every one of you behind that desk. He stated that they get to make decisions, policies, procedures that make people like himself get to go home and feel safe. It would allow the women in our city to not look over their shoulders and wonders who is protecting them. To allow more and more people to feel like this could be home, but how can this be home when we are not welcomed. How can this be home where at any moment anything can change. He stated that they watched policies get passed by this board and sat on for two years. He stated that they don't know what is going to happen next. We do know that we need change. He asked what are they going to do.

Mr. Don Ringer, 1801 Liberty Street, stated thank you and he guesses he does not have to mention his address. He just wants to say and he understands the value of prayer, but somebody has to be held accountable in this city for what the hell is going on right now. It is ridiculous what is going on right now. He asked where is our mayor tonight. This is an important meeting. He asked is the mayor here. Does anybody see the mayor?

Dr. Cynthia Mota stated we have the Chief.

Mr. Don Ringer asked did anybody see the mayor. He doesn't even show up tonight. It is unbelievable. Secondly, he has watched Chief Roca and supported him when he became Chief. He stated that he really did and considers him a friend, but he has failed this city. He stated that they need somebody here to help. Officers are going into 7 Elevens and Wawa's today and being yelled rapists. Is that right for the Allentown Police Department. You know most officers in this city, a lot of officers are great officers. He stated don't get him wrong, but somewhere along the line this is going bad. Very bad. He is calling the removal of Chief Roca from the Allentown Police Department or at least a suspension until this is rectified right now. He said something doesn't make sense to him about the things he was told and the answers they are getting now. He stated something is not right. He can tell them another thing a lot of officers in Allentown, they don't want to work for Chief Roca. They really don't.

Dr. Cynthia Mota stated to Mr. Ringer that it is important not to shame the staff and city employees.

Mr. Don Ringer stated he is sorry Cynthia. He is also getting away from the Police Department. This mayor should be removed too. He is not a leader. He never was a leader. He stated that we need a leader in this city right now. A leader would show up here and defend the city or defend himself. He doesn't even have the guts to show up. He stated that something is wrong in this city and it needs to be addressed very soon.

Mr. Enrique Moreno, 333 N. Franklin Street, stated that he explained to someone and all the situation is not only for him. It is for everyone in the city. He has lived here for almost 28 years. Almost 30 years, but he doesn't know what they needed for Allentown. Everything is changing. For all the years and he doesn't know what sign for residents. Each one is politics. Council President who can work and take care some of the issues. All residents like his person or somebody else. He doesn't say everybody so they can work together. He stated they feel the discrimination with the Parking Authority and the Sweep Cleaner and personnel in Allentown. He stated that they have so many issues. All the people can come in here and if they can get signing for all the residents in his neighborhood. He lives by Wawa. The Parking Authority last year, they agreed they were not going to put tickets at 11:00 at night. People call him to work every night and about time he finishes his work at 2:00 in the morning. He works at the Fire Department in Bethlehem and come over night and he sees enough for him. People they don't find any parking. He can record all the street and you tell him they can't find parking. He stated that he accepted it. You can't find any parking in the town, right. It is not a big deal that people are coming. They pay more taxes. They make a business. They need to take care why these people come and bother when the people are working, living and finding in the morning and you see 12:00 in the afternoon you see a lot of parking. Overnight, it is full. It was not happening in 2003, in 2004, nothing happened like this. He asked how can they fix this. If somebody comes and tells him about his personal helmet and they can go together. They can go together and find out.

Dr. Cynthia Mota suggested to Mr. Moreno that he gives Mr. Hanlon your phone number and also your name. She asked him to write it down and she will be calling him personally.

Mr. Enrique Moreno stated that he doesn't want to bother nobody or keep coming back. He stated that they have to be flexible sometimes because if it something error, it is he accepted it.

Dr. Cynthia Mota stated that you can't find parking in the evening.

Mr. Enrique Moreno stated that the Parking Authority and the Sweep ticket with the city hall is got word back and came to him and talking to him like it's his mother. He told the person working for the city to relax. He stated first of all you have to talk to him nice. He stated that he will leave his information.

Dr. Cynthia Mota stated that she will contact him tomorrow.

Mr. LeRan Odeleye thanked Council for giving him this opportunity to talk

and he is glad she update what happened regarding the incident where somebody put a noose on the table of the worker here in city hall. It is like every time one turns around there is always a case of an African American in the high ranking locator of the city been sacked. He is beginning to wonder is there a problem or a city or something that affects African Americans that are in the ranks of the city. He stated that it is getting very concerning. He is trying to reflect that every time someone turns around a high ranking African American and the member of the city workforce is been sanked. It has been let go. It is beginning to get concerning that someone gets very brazen to walk into a secure building and into a secure office to place a hanging noose on the desk of their coworker. Something just has to be done. He is glad that they mentioned they got the FBI and the local authorities involved. What is the next line of action here? Because we can't afford to let things like this keep happening. He stated threatening the life and the livelihood of an African American in this city.

Pastor Myria Bailey Whitcomb stated good evening and appreciates this opportunity. She stated that she doesn't live in Allentown, but she is a Black woman and there was something very disturbing to hear that a noose was placed on another woman's desk. She stated that what really disturbs her is how is it possible that someone could be that bold and feel that they can actually place a noose on someone's desk and there is no reprimand or they are allowed or excused away. What happens to the woman's feelings of working around her coworkers and not knowing who did what, but still trying to trust people to do her job. Who stands behind her? Who makes sure that she is ok? Who affirms her and other Black women as well? The noose has such a historical reference to it that it goes way back to slavery and then to use those tools in 2025 as though we haven't grown it says to her then there is a problem in this system. And, so, where do we fix the problem in the system. What are the answers? It all can't come from the community. The community complains, but yet, this has been a complaint that has going on for a long time. When do we get to actually moving on the complaints and actually making reform and changes that everybody can live with and that everybody can feel as though they are important in a city. What they see, what they do, how they feel that there are people that are concerned about them. It really makes no sense, honestly that we haven't moved forward and we haven't gone further than this. This is 2025, really? And, this isn't the first time we heard of this. If leadership is going to be on boards. Leadership is going to be recognized, and then leadership is going to have to be responsible to at least try to come up with a document that looks like you are working on it. That may have suggestions and as community members who live it, what should be on there. It can't come from the leadership because you are too high up, but it needs to be spoken about from the people who are experiencing it every day. There are experiences that we don't get to hear

of because they are not the type of folk that are able to come and speak for themselves. She stated that she just came to mention that and to say that. The women, especially, the Black women need to be protected.

Mr. Michael Hanlon stated that he believes the rest are here to speak on Bill 4. He stated that Ms. Blanco is going to have to tell him that is the case. Ms. Elizabeth Polanco will speak on the Trust Act. He asked is that the Immigration Legislation.

Dr. Cynthia Mota stated to Ms. Blanco, Mr. Hanlon is asking if you are speaking on the Immigration.

Mr. Michael Hanlon stated that the Rules are that under Courtesy of the Floor, you can speak to items that aren't on the agenda and since the Immigration Bill is on the agenda, that is Bill #4, you will have to wait until that time to speak.

Dr. Cynthia Mota spoke in Spanish to explain the process to Ms. Elizabeth Blanco. She stated next.

Mr. Michael Hanlon stated that he doesn't have anybody else.

Dr. Cynthia Mota stated that now they are going to have the election of President and Vice President. She asked if there were any nominations for President.

The Committee met this evening; there is one item on the regular Agenda concerning the Fire Department. There are no future meetings scheduled at this time.

The committee has not met since the last council meeting. There are no future meetings scheduled at this time.

#### Controller's Report

Mr. Jeffrey Glazier thanked Mr. Hendricks and stated congratulations on your election. He stated that he has this evening a brief Report on the P-Card Review for the month of August of 2024. You might say, gosh, it's January and you are jut getting to August. He stated that he agrees with them. The number of P Card Statements reviewed for this period was 69. The number of documents in that review was 644. The total dollar amount was \$252,591. Over a year ago, the city brought the city garage back in-house and it that resulted in a significant increase in the number of documents reviewed in P-Cards every month. Prior to the garage being in-house, they might do 400 invoices in a P-Card Statement. This P-Card Statement had 644 so you can see the amount of work on the accounting side that bringing the garage back in-house has created. It probably keeps the Clerks in the garage very, very, very busy. The garage is working towards finding more efficient ways of paying their bills. Maybe getting the vendors to send a monthly statement, individual invoices attached. He stated that they can pay them on the normal check run and that takes the pressure off P-Cards. There will be fewer invoices here. His office will still deal with the same amount of invoices. The garage will still deal with the same amount of invoices, but will be able to pay in a more timely manner and they have the chances of holding this report as the volume will be decreased. He stated that he hopes that will be fully implemented this calendar year. All P-Card invoices are supposed to be entered in a three day which is the close of the period that unfortunate doesn't happen. Once again, evidence of the fact that they just completed the August Report. He stated that September will be done shortly, by the way. There were 46 entries that was entered after 10 days. There were 30 invoices that was less than 30 days. Between 31 and 60 days, there were 14 invoices outstanding and over 60 days, there were two invoices outstanding. While they made some improvement there, once again, things that are over 31

days slows this process down. Really anything over 10 days slows this process slows it down. Sometimes, there are reasons. There are problems that need to be worked out, but not in all these cases. Beyond that, they had one finding within an inadequate segregation of duties. Somebody who expended the money was also part of the approval process. They advised the administration of the issue and going forward the responses going forward, the employees banner signatures will be required on those receipts. The signature on the receipt would provide the approval of the P-Card transaction itself and that information will be attached to Eden. They had one invoice where freight was paid twice. The department was advised and seeking a refund from the vendor. There were some travel invoices that had tax, that the tip was paid in a percentage greater than 20 percent. The department was involved and they calculated the tip on the amount including the tax when the well accepted custom is to tip on the pre-tax amount. There were 24 invoices where the wrong expense account was used. The departments were advised and journal entries were created to correct those issues. One of the problems, that they are going to run into reviewing these statements so late is that the year closes at the end of February. He stated when they do the December Statement, on February 26th, and people need to make journal entries, they may not be money in the accounts where they need to make them to. They will still note it and expect it and a performance will significantly improve for next year. Another issue they have occasionally is credit card fees. If you come to the city you want to pay your bill, the city will charge a convenience fee. other vendors do that as well. Currently, that is against city regulations. They don't want to pay credit card fees. If you run into that situation and really what the department needs to do is get a Requisition and put out a PO. He stated sometimes you can do that. Sometimes you can't. Sometimes companies change their policies and decide, oh, now we are going to charge a credit card fee where they have not done so in the past. These fees do not get refunded. The city points them out. He stated that he s not honestly sure what the solution is Mr. President, you need to just be accepting these things or departments need to create a list of vendors that charge fees so that the departments are aware in advance and can use Purchase Orders. He stated that is his Report this evening.

Mr. Daryl Hendricks thanked Mr. Glazier.

Mr. Daryl Hendricks asked if there were any questions, comments from the dais.

Mr. Ed Zucal stated that when this initially started, this investigation, the part that started when Council sued the mayor, they approved a \$20,000 allowance for that part of that investigation lawsuit. Now, because they are planning to go a different route, some say that this is going to be more cost effective. He stated that they are now increasing this already at \$30,000. More money to the taxpayers and they have not even begun to start Plan B. He stated that he will not be voting for this.

Mr. Daryl Hendricks thanked Mr. Zucal and asked if there were any other questions or comments.

Ms. Ce Ce Gerlach stated that on the off chance that this did not pass, this is essentially paying Ms. Brown for her services. She asked is she correct.

Mr. Michael Hanlon stated correct and can he say this, he doesn't have the

bills in front of him. Most of this bill is up to the litigation. A little part of it is the post litigation discussion. He stated if that makes sense to you.

Ms. Ce Ce Gerlach stated that it was pre-litigation.

Mr. Michael Hanlon stated that previously, they do not have enough money, Mr. Zucal when they were involved stating you know what I mean. There are additional funds for the work that Ms. Brown did with Ms. Montero to work with the Solicitor's office.

Mr. Ed Zucal stated that they don't know how much is post litigation.

Mr. Michael Hanlon stated that he sent Jeffrey the bill.

Mr. Jeffrey Glazier thanked President Hendricks and Mr. Zucal and stated from what he can determine with Mr. Hanlon's help and Ms. Whitehead's help and Ms. Montero's assistance, the total cost of your Counsel so far is over \$65,000. There may be some smaller bills coming to represent the time after the court date where she has worked with Council on in working with the administration. Those bills have not been sent yet nor to the best of his knowledge that firm giving any idea what those bills will amount to. He stated really, as Michael said the transfer is really recognizing that you need money to pay for bills that you already incurred to this point in time.

Mr. Daryl Hendricks thanked Mr. Glazier.

Mr. Ed Zucal asked if he could just follow up on that. He stated it is definitely more than \$65,000 because the investigator's bill alone is more than that. He stated as far as for the attorney, she has to be paid for what she did. That is his issue here. He doesn't know how much or they don't have a factual number on how much post litigation it is.

Mr. Jeffrey Glazier stated that he is going to ask Council's Solicitor.

Mr. Michael Hanlon stated that Ms. Montero sent them that.

Mr. Ed Zucal stated you asked for them to respond.

Mr. Jeffrey Glazier stated that he will ask the Solicitor to weigh in if she thinks he is misspeaking at all. That is to be determined. He would expect the rate of increase would be significantly less than preparing for litigation as she counsels and advises your guys. He stated that they won't know until they know.

Mr. Ed Zucal stated that they already asking for \$50,000.

Mr. Jeffrey Glazier stated \$50,000 plus \$20,000, takes you to \$70,000. You have a little bit of a cushion there and yes, conceivably you are going to need a little bit more money to make her whole.

Mr. Ed Zucal thanked Mr. Glazier.

Mr. Michael Hanlon asked if everyone is good with that answer.

Ms. Ce Ce Gerlach stated boy does she have questions and concerns when it comes to the investigation and the new route that some folks on Council would like to go down. She stated similar to Mr. Zucal, if someone is doing work, they need to get paid. She stated it's like Mr. Curtis needs to get paid. This attorney needs to get paid since she did work. It is not her fault that there was a shift amongst some folks on Council. She stated that she will be voting yes.

Mr. Daryl Hendricks thanked Ms. Gerlach. He asked if there were any questions or comments from the public.

Mr. Ed Zucal stated that if he must say before she speaks, no disrespect, he will vote yes because up until this point they need to pay her and also negotiate after that.

Ms. Karen Ocasio, South Allentown, asked has this already been said that you guys decided to move to a law firm to do the investigation or are you guys still debating on.

Mr. Daryl Hendricks stated that is still under consideration. That has still not been decided as of yet.

Ms. Karen Ocasio stated that her question is how is this being voted on because she thinks it is unethical and it should really be illegal that people who are being investigated are even voting on this investigation that are on the Council. You guys should really excuse yourselves from here and let the people who are not being investigated do the decision. It is a complete conflict of interest. The ones who are being investigated should really excuse yourselves from voting on this.

Mr. Daryl Hendricks thanked Ms. Ocasio. He asked anybody else from the public.

Mr. Daryl Hendricks thanked Mr. Hanlon.

Mr. Michael Hanlon stated that you had some folks that signed up to speak to this.

Mr. Daryl Hendricks asked if there were comments or questions from the public.

Ms. Elizabeth Polanco stated thank you for the opportunity and gave her name. She stated that she is a United States citizen and also an immigrant from the Dominican Republic. She stated that she believes this law and act must pass so that immigrants are protected and they feel confident in life, safely in the city. That they feel safe going to the hospital, school, and the police department. This city must not share the immigration status of the people. This is accordance with laws that already sit such as when with a judge. She stated thank you so much and thank you for the opportunity. She spoke in Spanish stating she has people speaking Spanish too.

Mr. Daryl Hendricks thanked Ms. Polonko.

Mr. Josie Lopez state hey City Council and this is her first time doing this. This is specifically about this Welcoming Policy. She stated that we need to be able to keep families together in Allentown. If we believe in that, then they need to codify a policy that says that. There has been a lot of reason why public trust has been eroded within city hall, specifically with this Council. Words are simple not enough. She stated that we need to have codified policies to keep federal agencies working with themselves and keep tax dollars in the city away from them. Something she realized this week is the saying that there ain't power like the power of the people because the power of the people don't stop. A lot of things happen this week and a lot of people are in this room because they showed up because they believe in things. A lot of other things move forward perhaps in other areas because the power of the people decided to pick up their phones and notify things and agitate in the right places. Hopefully, you will hear enough from the citizens. You will know that Allentown is a majority minority city. A large portion of our citizens don't even speak English. She stated that we need to protect them. ICE is not welcomed here. Allentown should be a welcoming city. Not a city that endorses hate in any of its forms and through any federal agency that breaks apart families and encourages hate. She said let's be a welcoming city, right and stated we want that. She stated that we want to welcome and be supportive in paper, not just by language. She would say that she would happily be more interested in supporting someone vocally for mayor of City Council that would be vocally supportive on codified paper supporting immigrants in this city.

Mr. Jon Irons, resident of Bethlehem and a Lehigh County Commissioner, stated that he is here to speak in favor of Bill 4. The Welcoming City Policy codification. He thanked Councilwomen Gerlach for introducing this legislation and bringing this conversation to the floor. He stated that he is also an immigrant. He stated that he was born in Ecuador and moved here when he was an infant. There is a couple of things he wants to address with this Bill, one, is that this is an opportunity for this body to be proactive. To get ahead of issues that likely is going to be coming down the pike, given the rhetoric and the plans of the incoming presidential administration. Currently, he has seen this Council working reactively. You have lawsuits, you are suing the mayor, you are dealing with Equal Opportunity Complaints, you dealing with Whistleblower cases. He stated that 10 years ago, they had a Galarza Case that a man was unjustly confined in Lehigh County jail at an Immigration Detainer and in response to all of those things, it is unfortunately that our bodies act reactively. We wait until there are cases. We wait until there is pain. We wait until there are complaints. We wait until there is a room full of people asking for desperate changes rather than being proactive. In this moment, they have an opportunity to codify some policies to make some very targeted structural changes to how data is managed in the city that would get ahead of complaints, and pain and potential liability for the city and the county in the next incoming next four or five or 10 years or how long we are going to be dealing with this type of anti-immigrant sentiment in our federal government. It is not unique to republicans. The other thing this Bill does, it addresses an issue with data management. In his professional capacity, he is a data manager. He thinks about this in his capacity as the County Commissioner and the fact that municipal governments are vulnerable to hacking. Municipal governments also hold a great deal of sensitive on or residents in our database. He stated that they share that information with law enforcement, we share it with third party providers and contractors at different times and decisions about very sensitive information and talking about information on national origin, language and you could include information on sexual identity and gender identity. These pieces of information are very important. He stated that the city should do everything it can to protect that information from possibly being leaked. One way to proactively do this is to codify policies that they are not going to share this information except for legally necessary and have some sort of impact on offering city services that provide support to people. He stated that he really wants to think about these two things, being proactive and protecting or data. The last thing this ordinance does is provide a sense of security for himself and other immigrants who are gong to be potentially talking about this. He stated that they need to see their bodies working together. He stated that they need to see governments across Lehigh Valley coming together to protect our valuable and cherished immigrant community. This will give you the opportunity to be the first municipal body to take real action on this in the Lehigh Valley and be a leader on this. He stated that f they do, he will absolutely follow them. They already working at the county to work on similar things. This will not happen in a vacuum.

Ms. Sharon Finnegan, Shantz Road, stated that she was looking earlier today and Lancaster, Pennsylvania did this already. They prevent local police and any city officials from inquiring a person's immigration status, unless it is required by state or federal law or court order or reasonably necessary in a criminal investigation. The importance of that is that people have to feel safe. She stated that we have seen the ugliness that happens. It is important that people: immigrants, asylum seekers, refugees can feel comfortable seeking city services. Reporting crimes if anything happens. She urged Council to pass this.

Mr. Michael Hanlon stated that is it.

Mr. Daryl Hendricks asked is there anybody else that wishes to speak on this topic.

Attorney Maria Montero stated that as with all the other Bills that were introduced, it is still information and things can change before the final vote and so on January 29th, it is the opportunity to see if it is the Bill you would like to move forward and vote on to talk about the details, especially moving forward in the investigation if that is what Council wants to use a law firm or other methods and if it does after the comment period through and it's on before Council and the majority of Council voting for that, four individuals.

Ms. Ce Ce Gerlach asked on the 29th, are we expected to make a final

vote that evening to either hire or not hire Duane Morris or amendments or motions. She asked is that the be all to end all on the 29th.

Attorney Maria Montero stated to her understanding the way you are putting forward ordinances is that you are required to give two weeks notice and she believes that is the goal of the individuals who put this forward.

Ms. Ce Ce Gerlach thanked Attorney Montero for those answers.

Mr. Daryl Hendricks stated ok, anybody else.

REFERRED TO THE COMMITTEE OF THE WHOLE ON JANUARY 29TH AT 6:00 PM

Ms. Barbara Redmond asked what happened to the old investigation. She stated that you s, then we are going to get someone new on top of that to come in. She stated that she doesn't understand what they are doing.

Mr. Daryl Hendricks stated that they hope to do that. They hope to come to a resolution.

Ms. Barbara Redmond stated that the money coming from the citizens don't have money to be spending and wasting money. She asked what did he do or what's wrong and why can't he be the person that does the investigation. She stated that they all agreed with it in the beginning. She asked what happened. Is it because the fact that you all are mentioned in the lawsuit. The new lawsuit that is out. What is going on? What happened that you changed your mind?

Mr. Daryl Hendricks stated that what happened is that they got tied up in the courts and they would be spending a lot more money and a longer time to get a resolution. That is part of the problem.

Ms. Ce Ce Gerlach stated point of order. She stated that she believes Council doesn't do a dialogue with members of the public.

Mr. Daryl Hendricks stated ok.

Ms. Barbara Redmond stated ok. She stated that she doesn't understand.

Ms. Ce Ce Gerlach stated that this is not a question and answer session. She stated that is what Dr. Mota always says. She stated just a point of order if she is wrong.

Ms. Barbara Redmond stated that her point is that she does not

understand. She stated that you get a law firm and the law firm has Rules and Regulations. When you hire a law firm, a law firm is for the person who is hiring them. She stated that you will be hiring that person. That person is going to be bias to whatever you all want to hear. When you have a law firm, a law comes in and talk to the employees. It is confidential between the lawyer and the person. If the mayor decides that he does not want to release that information, the lawyer is going to be bias. Why can't a consultant company come in and do a thorough investigation. Why do you need a lawyer? Is anyone friends with this company? Does anyone knows this company? She stated and another thing, the people who were included in these lawsuits are you all going to be eliminated from voting because she feels like there is a conflict of interest to pick another law company when people are involved in it. The people who are involved in lawsuits should not be a part of the lawsuit and a rephrased stating picking and choosing what firm you are going to have. You are talking about this one firm. What other firms were mentioned? What other firms are mentioned?

Mr. Daryl Hendricks suggested to attend the meeting on the 29th. You can ask those questions or make those statements.

Ms. Barbara Redmond stated that she will, but hope that they are not going to have one law firm that you wanted or already selected. It is not fair to the community. She stated that she will definitely be in that meeting.

Mr. Daryl Hendricks asked is there anybody else.

Ms. Kari Holmes stated to Mr. Hendricks that she wanted to ask if there is a feasibility to offer a community dialogue of invited the community back maybe prior to the meeting that is scheduled or for instance, if the and she wants to make the suggestion because there is a lot of speculation around this and she believes they are not making the distinction as clear as it needs to be to the community that these are different lawsuits and different pieces of litigation in addition to what City Council has adopted and agreed to address with the mayor. That is something separate and different than the other concerns that have been presented regarding City Council members. That does not mean that the concerns of your constituents you heard them this evening regarding reusing yourself and so on should not be considered. She stated that it would be helpful to either have a meeting prior to the one you are going to have on the 29th or possibly a half hour of explanation. Maybe at that time, you don't take comments from the community, but you explain some of the nuances. Obviously, a lot of this stuff is discussed on Facebook, there are round about conversations on social media, but you also have your constituents quite honestly may not know when the meetings are. They may not be

understanding the rhetoric or the rhetoric itself may not be clear as to what the particular litigations are, who are involved in them and who will be adopting them to move them forward. For instance, again, she would just offer that as a suggestion as a way of communicating if the meeting is at 7:00 then invite the public to a listening session at 6:30 PM or maybe you will have comments at 6:00 PM. She stated then you will explain what exactly is about to take place at 7:00 PM so they have an opportunity to clearly understand . She stated that she is sure Council can hear this evening while people have heightened concerns, there are also a number of concerns as issues that are very and said she does not what to say convoluted because they are connected, but Council can give some clarity for them as constituents as to what is happening where and if indeed, anyone should not be recusing themselves then they would be able to give a sold basis as to why. Again, creating that place of dialogue and understanding with your constituents and stated that she hopes they will consider that.

Mr. Daryl Hendricks stated that they will certainly meet on the 29th and those questions will be raised and stated that the mayor had absolutely nothing to do with Council's decision about whether they are moving forward or how they are moving forward. It is done by Council and Council alone.

Ms. Kari Holmes stated that she understands that, but does believe that Councilwoman Ce Ce Gerlach, your peer made a good point that it is here tonight may not avail them with the opportunity to hear from you as president of City Council or your peers as to what has been done in a positive direction. She stated that she believes the community is saying we want to hear what you have done so far and she believes they are in a position to share that with them, but tonight at the City Council meeting may not be the place to do that. On the 29th, you have to move things forward a well. She stated that it might be a need for and she knows that City Council works hard and you have your own families.

Mr. Daryl Hendricks stated that on the 29th, they can discuss it in full length.

Ms. Kari Holmes thanked Mr. Hendricks and stated that is helpful.

Mr. Daryl Hendricks stated that it is appreciated.

Ms. Karen Ocasio asked was there an RFP for this. How was Duane Morris chosen so quickly. She asked was there an actual RFP done. Because wasn't there a concern with what was his name, Scott Curtis. How quickly things moved. She stated, oh, we are not answering. That's right. She stated that was her questions because she doesn't remember seeing an RFP and how they got chosen so quickly. She stated that she just wants to know how that process went. She stated that if they can get the clarification on that as well.

Mr. Daryl Hendricks thanked Ms. Ocasio. He asked if there were anybody else. He stated again, this will be referred to the Committee of the Whole on January 29th at 6:00 PM.
