ACCOUNTS PAYABLE WEEKLY CHECK REVIEW

For the Check Period end date: 11/01/2025 – 11/28/2025

Date of Report: December 10, 2025

OBJECTIVE

The objective of the weekly Accounts Payable check review is to determine whether the checks issued, and their corresponding documentation comply with the requirements of the policies, guidelines, and procedure outlined in the AIMs and to identify any areas for improvement.

Overpaid Travel & Expense Advances and their corresponding documentation are being reviewed to determine whether they comply with the requirements of the policies, guidelines, and procedure outlined in the AIMs and to identify any areas for improvement.

Effective 12/2020, outstanding invoices in MUNIS over 30 days are being aged and reviewed to determine why they remain unprocessed and to identify any areas for improvement.

PROCEDURES

A review of all the checks and wires generated for the period tested including a review of the invoices being paid and their corresponding documentation, approvals, compliance with AIMs and reasonableness of expenditure.

Of checks and wires reviewed and posted for the period: 447

\$ Amount of the checks reviewed and posted for the period: \$10,131,527.27.

Of manual checks reviewed and posted for the period: 9

\$ Amount of the checks reviewed and posted for the period: \$141,091.25.

FINDINGS AND RESOLUTIONS

1. Incorrect Expense Account Used

EMS charged 1 (one) invoice totaling **\$1,850.00** for LETTERING to AC 50068 – Operating Material and Supplies. The expense should be charged to AC 50046– Repairs and Maintenance.

Resolution

The Bureau was advised of the issue and submitted journal entry corrections.

2. Late Fee Paid

We identified 1 (one) BUILDING MAINTENANCE invoice which included a late payment fee totaling **\$2.12**.

Resolution

BUILDING MAINTENANCE was advised of the issue.

3. Untimely Payment of Invoices

Although not all vendors have the same payment terms, the prevailing vendor payment terms is net 30.

Currently, the City does not have a standard for the time frame invoices must be entered in MUNIS, go through the MUNIS approval queue, and finalize for payment.

Although there is no City standard for the invoice payment process, the Controller's Office uses a 60-day measure to flag any potential untimely invoice payments.

Untimely payments may result in:

- Missed discounts,
- Vendor imposed late fees,
- Possibility of the City's account being placed on hold, and
- Additional workload with the vendor's Accounts Receivable and the City's AP departments.

- 10 (ten) checks for 13 (thirteen) GARAGE invoices dated 04/2025, 05/2025, 06/2025, 07/2025, and 08/2025,

- 3 (three) checks for 3 (three) FINANCE invoices dated 05/2025 and 06/2025,
- 2 (two) checks for 4 (four) TRAFFIC PLANNING invoice dated 05/2025, 06/2025, and 07/2025,
- 1 (one) check for 5 (five) BUILDING STANDARDS & SAFETY invoices dated 06/2025 and 07/2025,
- 1 (one) check for 1 (one) TREASURY invoice dated 07/2025,
- 2 (two) checks for 26 (twenty-six) PARKS & RECREATION invoices dated 07/2025 and 08/2025,
- 5 (five) checks for 5 (five) FIRE invoices dated 07/2025 and 08/2025,
- 1 (one) check for 3 (three) PLANNING invoices dated 08/2025,
- 1 (one) check for 1 (one) RECYCLING AND SOLID WASTE invoice dated 09/2025, and
- 1 (one) check for 1 (one) IT invoice dated 09/2025.

Resolution

All Bureaus were advised of the issues and the checks were released.

EMS – Per EMS, this was a mistake, and the invoice was received recently.

MAYOR’S OFFICE - The invoice was entered in April. It sat in the approval queue for quite some time. When the vendor asked about payment, MAYOR’S OFFICE realized the invoice had been rejected. MAYOR’S OFFICE then entered a requisition for a purchase order. After the PO was processed, MAYOR’S OFFICE overlooked the final step of receiving the invoice in Munis.

POLICE – The invoice was not received until 11/2025.

GARAGE –

- 04/2025 and 06/2025 Invoices: The invoices were submitted late due to the ongoing situation involving the vendor. At the time, it was unclear whether the vehicles would be delayed or when they would be delivered at all. Because the parts on these invoices were specific to those vehicles, GARAGE was advised to hold off on processing payment until the vehicles had arrived.
- 05/2025 and 08/2025 Invoices: No response was received.
- 06/2025 Invoice: The invoice was entered late because GARAGE was initially unsure whether it was a reimbursable expense. While GARAGE was attempting to determine the correct account to charge, the invoice was inadvertently missed.
- 07/2025 Invoice: The invoice was received late.
- 07/2025 Invoice: The invoice was submitted late because the blanket PO did not have sufficient funds available at the time, and then GARAGE had to wait on a budget transfer to go through to replenish the blanket PO.
- 08/2025 Invoice: The outstanding invoice was missed and discovered on the vendor statement.
- 08/2025 Invoice: The outstanding invoice was missed due to focusing on other work and was paid when contacted by AP.
- 08/2025 Invoice: No response was received.

FINANCE - The delay in submitting the invoices for payment was due to the review of charges on the invoices.

TRAFFIC PLANNING –

- 05/2025, 06/2025, and 07/2025 Invoices: The invoices were delayed in processing as TRAFFIC PLANNING did not receive confirmation on delivery. Additionally, there was added shipping on one of the items, and one of the invoices appeared on two separate POs which led to a delay in processing while trying to figure out what had happened. Once this was figured out the invoices were processed and the proper POs were charged and payments released.
- 06/2025 Invoice: The invoice is associated with the grant assistance contract and must be reviewed and verified by the Engineering and Traffic department to ensure all work aligns with project standards and specifications. Payment to the vendor is held until the review is complete. Additional time was also required to finalize and submit the grant application itself, contributing to the delay.

BUILDING STANDARDS & SAFETY - BUILDING STANDARDS & SAFETY recently received a flurry of older (from summer) invoices from the vendor. BUILDING STANDARDS & SAFETY is in the process of increasing the current blanket PO to accommodate this influx of invoices.

TREASURY - The invoice needed a budget transfer to be completed. The budget adjustment was done mid-October after being approved by City Council.

PARKS & RECREATION –

- 07/2025 Invoice: The vendor swiped but failed to charge the PCard at the time of purchase. After multiple unsuccessful attempts to pay the vendor, PARKS & RECREATION was given permission by Purchasing on 10/24/2025 to enter as a requisition.
- 07/2025 and 08/2025 Invoices: Invoices held for contract increase.

FIRE –

- 07/2025 Invoice: The invoice was inadvertently filed away and was paid when FIRE was contacted by the vendor.
- 08/2025 Invoice: FIRE was not aware items shipped as the Commander of the Safety committee never provided notification that the order was received and complete.
- 08/2025 Invoice: Original invoice for this August service was received on 9/04/2025 via USPS. The original invoice had incorrect unit costs.
- 08/2025 Invoice: FIRE was not aware that the unit was returned. FIRE had a change in leadership and until they could locate where the unit was and that it was in operational condition the invoice could not be paid.
- 08/2025 Invoice: FIRE was waiting for a transfer of budget funds to be approved through City Council before a change order to the Purchase Order could be done and then received for full amount.

PLANNING – The Manager was out on bereavement leave and upon returning discovered that August invoices were not paid.

RECYCLING & SOLID WASTE - There was a big delay in production. The order was split, and RECYCLING & SOLID WASTE had to wait for the full order to be completed before releasing payment.

IT - IT had to wait for a department to transfer money into their printing account to pay the invoice.

4. Documentation Not Attached in MUNIS

To provide a proper audit trail and document the expenditure, the hard copy of the invoice and all pertinent payment information is scanned and attached in MUNIS.

For the period 11/01/2025 – 11/28/2025, the following departments did not have the proper documentation attached in MUNIS:

- PARKS - 1 (one) instance.

Resolution

The Bureau was advised of the issue, and the proper documentation was scanned.
