- Description of project or scope of services to be provided:

On November 21, 2023, the City advertises a solicitation for Turf Chemicals, the intent of this bid is to secure a supplier(s) to furnish agricultural chemicals for the City of Allentown. Quantities are estimated and shall be purchased at the unit prices identified on the bid tabulation. The City has allocated funds in the Budget to cover the cost of the chemicals. Based on estimated quantities provided during the bidding process, the annual estimated budgeted amount for the turf chemicals awarded to these vendors is \$220,800.00. The quantities provided in the bid are estimates, and as such, the actual cost of the materials may vary throughout the year based on the needs of the departments. The Contract term shall commence upon full execution and cease December 31, 2024. Upon written notification, this contract can be extended for up to two (2) additional one (1) year terms beyond the contract expiration period. On December 19, 2023, there was a public opening held, five (5) bids were received. Upon review of said bids, each was awarded various parts of the contract, as indicated in the Bid Tabulation.

The Contract term shall commence upon full execution and cease December 31, 2024.
