AN ORDINANCE

Amending the 2025 General Fund and Information Systems by deleting the position of Application Developer (14N) with the salary budgeted in the amount of Seventy-Nine Thousand Seven Hundred Ninety-Four (\$79,794) Dollars; and creating the position of Systems Analyst 1 (12N) with the salary budgeted at Seventy-Two Thousand One Hundred Nine (\$72,109) Dollars.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 165 of the General Fund budget be amended by deleting the position of Application Developer (14N) with the salary budgeted in the amount of Seventy-Nine Thousand Seven Hundred Ninety-Four (\$79,794.00) Dollars; and creating the position of Systems Analyst 1 (12N) with the salary budgeted at Seventy-Two Thousand One Hundred Nine (\$72,109.00) Dollars.

SECTION TWO: That this Ordinance will take effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
