AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for a supplemental appropriation of Ten Thousand Dollars (\$10,000.00) from the Ferber Company for traffic signal improvements.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes an increase to the unappropriated balance of 2024 Capital Fund in the amount of Ten Thousand Dollars (\$10,000.00) as follows:
