Authorization for Contract with Bethlehem Landfill Company in the estimated amount of \$2,954,870.00 for the first contract year, with a maximum CPI adjustment of five (5%) percent to be applied for contract commencement on 6/1/2025 and each year after the first-year term, to provide disposal of municipal solid waste (MSW). There were three (3) bids; contract shall be for five (5) years beginning on the commencement date, June 1, 2025, and terminating May 31, 2030 and can be extended for up to an additional two (2) two (2) years beyond the contract expiration period at the sole discretion of the City.

**WHEREAS**, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Bethlehem Landfill Company
2. Project or Contract Reference: RFP No. 2024-25 Municipal Solid Waste Disposal
3. Description of Service(s): For the disposal of municipal solid waste (MSW).

Pursuant to City Ordinances, Article 130.16, this Recommendation of Award is before City Council for its approval and award of the contract.

- Check Type of Contract or Change:

Awarded contracts over \$40,000.00 done through cooperative purchasing.

The contract is for over \$40,000 and required to be competitively bid under the City Code. We have advertised the above referenced project and received qualified bids/proposals.

- Description of project or scope of services to be provided:

On May 1, 2024, the City advertised a solicitation for the disposal of municipal solid waste (MSW). On June 21, 2024, there was a public opening held, which three (3) proposals were received and distributed to all committee members via Teams for evaluation. The Technical evaluation was held on June 26, 2024, all committee members were present. The proposals were scored based on the following: IBE Preference (10 Points), Experience, Qualifications and Prior Performance (20 Points), Resources (20 Points), and Implementation (20 Points). The Cost proposals were opened on June 26, 2024, and distributed to all committee members via Teams for evaluation after the completion of the Technical evaluation. The Cost evaluation was held on July 1, 2024, all committee members were present. The committee members discussed the Cost proposals (40 Points). The committee made the recommendation to proceed with oral interviews (15 Points). The oral interview meetings occurred on July 10, 2024. Bethlehem Landfill Company at 10:00AM, Solid Waste Services, Inc. (d/b/a J.P. Mascaro & Sons) at 11:00AM, and Waste Management of Pennsylvania, Inc. at 12:00PM. All committee members were present. The evaluation committee completed both Technical and Cost evaluations on the proposals along with the oral interviews with all vendors who submitted a proposal. The committee decided to award based on the firms qualifications and overall score. The committee is recommending award to Bethlehem Landfill Company.

- Contract Term:

The initial term of this Contract shall be for a five (5) year period beginning on the Commencement Date, June 1, 2025, and terminating May 31, 2030.

- List any renewal term options and duration of each renewal, if any:

At the sole and absolute discretion of the City, this Contract may be renewed for two (2) additional two (2) year periods. The City shall notify the Contractor of its intent to exercise this renewal option or allow the Contract to terminate. Said notice shall be in writing and delivered at least one (1) year prior to the then applicable termination date.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

Estimated costs based on the annual adjustments assumptions of 5% CPI increase:

Year 6: \$3,681,968.32

Year 7: \$3,849,529.39

Year 8: \$4,025,319.52

Year 9: \$4,209,744.20

**Total Estimated nine (9) year Contract Cost = \$31,924,951**

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
