RESOLUTION

Introduced by the Administration on March 15, 2023

Authorizes the submission of the formal application to the Pennsylvania Office of the Budget for a grant in the amount of Six Million Five Hundred Thousand (\$6,500,000.00) Dollars to support the renovation and expansion of the Lehigh Valley Health Network (LVHN) 17th street facilities.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County and Lehigh Valley Health Network (LVHN) hereby requested a Redevelopment Assistance Capital Program grant for \$6,500,000.00 from the Pennsylvania Office of the Budget to fund the renovation of the 17th street facilities.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matthew Tuerk Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit and accept six million five hundred thousand (\$6,500,000.00) in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.
