AN ORDINANCE

Amending the 2025 Trexler Fund by authorizing a supplemental appropriation from the Trexler Escrow Unappropriated Cash balance in the amount of One Hundred Eight Thousand One Hundred Five Dollars and Seventy-Five Cents (\$108,105.75) to the MLK Trail capital account of the Parks and Recreation Department. These funds will be utilized for the construction of Phase 1 of the trail and is part of the 2024-25 Trexler Capital Project allocation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the Trexler Escrow Unappropriated Cash balance of the 2025 Trexler Fund in the amount of One Hundred Eight Thousand One Hundred Five Dollars and Seventy-Five Cents (\$108,105.75) as follows:
