Ms. Sarrah McNeil stated that this was done as RFP2025-50 MLK Trail Phase II Design Rebid. She stated that it was advertised on Public Purchase on October 2, 2025. There was a Public Bid Opening on October 31, 2025. The city received four proposals. An evaluation team consisting of four members conducted both technical and cost evaluations. The proposals were based on IBE preference, ability to meet RFP requirements, firms experience, project plan and cost. After evaluating proposals, the evaluation committee decided not to move forward with oral presentations. The committee is recommending an award to the highest scored vendor, Langan Engineering and Environmental Services LLC.

Mr. Daryl Hendricks thanked Ms. McNeil. He stated Mr. Zucal.

Mr. Ed Zucal stated that this is why we have no money. He stated that all the money they spent so far on this trail and you mean to tell him they have to hire someone to tell them whether or not, we need to make it eight foot or 10 foot.

Ms. Mandy Tolino stated that this is for our detail construction docs for everything. She stated not just for that one piece. She stated that it is the whole trail. The subbase, the design, and all the permits stating everything. She stated that there is MPBS, there is stormwater permits, city permits. She stated that it is the whole design of the trail. It is not just deciding what size the trail is. It is a full engineering of the trail, similar to if you are going to engineer a road to make sure it is structurally sound and the water

doesn't puddle and it is safer. It is similar to a road so it is a technical proposal.

Mr. Ed Zucal stated and you telling me all the other money we spent for these other contractors to build this trail haven't been able or can't do that.

Ms. Mandy Tolino stated that this is one section of it that is not build yet. It is not designed. She stated that is why you hear about it so often because they do a concept and then they will do the full engineering design. She stated that they did that for Phase I. She stated that this is Phase II. She stated so now they are starting again on a different section, totally from scratch. She stated that right now it is nothing there. It is a grassy area.

Mr. Ed Zucal stated just out of curiosity, how many sections are there going to be when it is all said and done.

Ms. Mandy Tolino stated so there are three sections. The first section is from the parking lot across from Parkettes. She stated some of that already existing. She stated it starts behind Fountain Pool, crosses over the bridge there to the other side of the creek and it connects to Lehigh Parkway by the apartments so that is Phase I. She stated Phase II connects from Lehigh Parkway to Union Terrace and then eventually to Cedar so they had to do Phase II A and II B because it came back expensive. She stated that they are breaking in the smaller pieces in order to get it done. She stated that these are grant funded projects. The third Phase they will connect from the Parkette's parking lot across the river to eventually the D&L Trail on the western side, like the raised grant area on Riverside Drive over there.

Mr. Ed Zucal stated that this \$233,000 is going to be grant money or no.

Ms. Mandy Tolino stated yes. She stated most of it is grant money.

Mr. Daryl Hendricks asked is all of it grant funded.

Ms. Mandy Tolino stated that she should not say it so confidently. She stated that she believes that most of it is. They received the funded from DCED state funding for most of the MLK project so far. She stated that none of it is city funds. It is ever grant for DCED or Trexler funding.

Mr. Ed Zucal stated ok. Thank you.

Ms. Mandy Tolino stated you are welcome.

Mr. Daryl Hendricks stated thank you and said Mr. Napoli.

Mr. Santo Napoli stated that back in July 20, 2024, he sounded the alarm on how investors were acquiring real estate in the city. He stated that at that time, the percentages that he came up with were 44 percent for a few months back in that timeframe. He stated that the finance department did a deeper dive and in over 18 months, they came in at 48 percent as an average. These investors are LLCs and corporations. He stated that the fear of investors inquiring much real estate and squeezing Allentown residents was a huge concern. He stated investors as you know come to the table with all cash offers. They have inspections and fast settlements and that entice the sellers to sell to them instead of homeowners and meanwhile Allentown residents are stuck renting and more times than not, higher rents. He stated instead of acquiring homeownership and build generational wealth, they just seem to be fixed in rentals and can't get out of that and can't seem to get out of that. He stated that one of the thoughts he had was too many rentals have a negative effect on quality of life and public safety. He stated that was a concern. He stated in this legislation tonight, is an opportunity to level the playing field for our residents. He stated that the 0.5 percent increase increases the deed transfer tax from two percent to 2.5 and that rate hasn't changed in almost 50 years. What that means for someone buying, the median home price in Allentown according to the realtors is \$241,000. For a buyer coming in and buying a home, it will mean an extra \$250 for every \$100,000 of real estate. He state so they are

looking at around high fives, early or low 600s extra for someone coming to buy real estate in the city of Allentown on a home of \$241,000. He stated what this legislation does not impact is our current city homeowner. He stated folks who live here, seniors on fixed incomes, some vulnerable residents stating that they will not be affected by this at all. Only the folks that are coming in and having the ability to buy property in the city of Allentown. He stated most importantly all the funds received from the 0.5 percent increase, exclusively goes into a Housing Fund under our CED department and that fund is going to be tasked with addressing housing initiatives in the city and as they all know most of Center City was built back in the late 1800s and early 1900. He stated that the stock is aging and it needs TLC, it needs work and it needs help before it deteriorates. It gets to a point where, it is very difficult to save. He stated lastly, a study was completed and many of you know that our CD department conducted a study called Welcome home. The City of Allentown has housing needs assessments. He stated for those of you, it is 90 pages and it is on the city's website. He stated that if you go to CED, you can click on it and it's a really good Report from a consultant on what needs to be done in the city of Allentown going forward and most importantly what the budget is. He stated that this legislation is providing a reliable source of revenue. He stated for us to or our CED department to accomplish these goals, we need a reliable source of revenue. Something they can count on year after year and this Deed Transfer Tax if approved tonight would bring in approximate \$3.2 million a year for them to accomplish their goal. Lastly, the public does deserve transparency and accountability so the legislation does mandate that the CED department must present an annual action plan to future City Council's detailing their plans each year of what they plan to do with these funds. Also, they have to present an Annual Report to detail what was actually accomplished and at the five year anniversary. They report from an independent source to be given to a future City Council detailing the effectiveness of the program and whether to continue to go forward. It is something that will give future City Council's annually a chance to understand what there plans are, what they are accomplishing and hold them accountable. He stated that is really a legislation there and regarding the funds every year regardless, they haven't gotten in exactly what they are going to do, but what they talked about based on the consultants' plan on home repairs for seniors and vulnerable residents who are at the risk of losing homes due to major repairs. They also talked about blighted homes and getting them remediated and back into the home the hands of homeowners and these goals can be accomplished with tools for instance using deed restrictions to make sure these properties are owner occupied going forward instead of rentals and also using liens so that when the property is sold down the road, the city gets that money back for the repairs. He stated that there are tools at our disposal that will continue to replenish the funds over the next decade or two decades. He stated that

there is a lot we can do. He stated that they can work with renters. They can work with a lot of different ways to help homeowners and residents in the city of Allentown and try to really address our housing stock. He stated that it really needs a lot of attention. It has been neglected for decades and this is an opportunity with a reliable source of revenue to actually start addressing some of our needs. Thank you.

Mr. Daryl Hendricks thanked Mr. Napoli and stated Mr. Zucal.

Mr. Ed Zucal stated that he just has one question for you. He asked Mr. Napoli how did he come up with the \$3.5 million.

Mr. Santo Napoli stated that the Finance Department did a Study and had based on previous years it was \$3.2 million he believes and had they done this a year ago, that would have been what the funds would have generated. He stated that this is based off data off the prior year just to give them an idea if this is worth pursuing if it came back hypothetically, if it came back at \$200,000. He stated that it is not worth it. It is not worth the squeeze, but \$3.2 million, that gives our CED department a lot of opportunities to start really addressing and accomplishing some of the goals that you are talking about.

Mr. Daryl Hendricks asked any body else and asked Ms. Gerlach.

Ms. Ce Ce Gerlach stated just a procedural question asking so then voting on this tonight they will make a statement if they want to raise by .5 percent, but in terms of the money going to the CED specifically the housing fund asking do we legislatively need to do something for that or since it is written here does it automatically and stated that she would just be honest what she doesn't want to see happen is that they do this Deed Transfer Tax increase and the money gets funny and it goes somewhere else.

Mr. Santo Napoli stated that it is in the legislation and pointed directly to the Housing Fund and he believes the Housing Fund, Mr. Hanlon was named in the legislation.

Mr. Michael Hanlon stated that it was named in the legislation and they were discussing that perhaps at the Budget Adoption that you might have to amend the General Fund Budget to account for the increase and flip the money into the Housing Fund. He stated that he is going to check with Finance and the Controller on that. He stated that the way the legislation was crafted was legislation basically points that the extra \$3 million will go to the Housing Fund and the thought process is that they will consult with Bina and the Controller on what might happen September 10th and that could possibly be bumping up the revenue item in the General Fund by \$3

million and indicating the Transfer of that money out of that Housing Fund. He stated that amendment will be prepared with the consultation.

Mr. Santo Napoli stated and to be clear, we wouldn't have \$3.2 million day one. It would take time to accumulate, but the legislation clearly states that it must go into a Housing Fund and it is under the CED department to be used for Housing initiatives for our residents in the city of Allentown.

Ms. Ce Ce Gerlach stated that if needed, there will be an amendment. She stated that she is going to vote yes. She stated that she doesn't think HOME was included in the recent state budget so they need it even more so now. There is not going to be money coming in to help people fix up their homes anymore.

Mr. Santo Napoli stated that is a great point and again, they are following the recommendations of the Study so for those who have not seen the Study, it is probably in the 80s, Page 80 something. He stated maybe early 90s, but there is a whole list of recommendations that the consultants prepared and they are going to work on that and have public meetings where they will discuss it and talk about what we are going to do.

Mr. Daryl Hendricks asked anybody else on the dais. He stated that he wants to commend Mr. Napoli for the initiative he took in addressing this issue. He stated that this is a serious issue. He stated that he does dabble a little bit and watch a lot of real estate going on and the amount of homes that are being sold to investors rather than homeowners. He stated that it is very concerning what's happening to the city overall. He stated that you can see it. These homes now are single family dwellings, are being converted where they are now two and three units. He stated as many as four units and it affects everything. He stated loss of parking and the one time he was able to because a friend of his lives in Center City, he would go there and never had a problem with parking. He stated that sometimes he has to circle the block four or five times to find parking. He stated that it is something that is needed, keenly needed. He stated again, he commends him for this. He asked anybody else on the dais or any comments from the public.

Mr. Kyle Ropski, 528 N. Berks Street, stated that he is here on behalf of Allentown Environmental Advisory Council to express support for the Resolution here before you guys here tonight which reaffirms the city of Allentown's commitment to limited responsible herbicides use and continued advancement of sustainable land management practices within our parks system. He stated that as you all know the city of Allentown Parks Department maintains an extensive network of parks, public spaces, naturalized areas. These places represents some of our most valuable public assets and their stewardship requires approaches that are both environmentally sound and operational effective. He stated that he wants to give a huge shout out to the Parks and Recreation Department and the maintenance crew there. They did an incredible job. It is a huge task. He stated just acknowledging them there. He stated now over the summer, the Allentown EAC in collaboration with Muhlenberg Colleges Office of Community Engagement and had a summer intern who focused researching on invasive species and unfortunately, was not able to come here tonight to speak on the research due to the last minute scheduling conflict. However, there were several key findings in her Report which is available to view on the new website: AllentownEAC.org. He stated that these are the chemicals that they spray among living things and they die. He stated definitely not good to be putting out in the community. He stated equally as important is the city's proactive adoption of sustainable alternatives with techniques of expanding native planting, time cutting, and other chemical or ecological strategies proving effective and managing invasive species while simultaneously supporting pollinators, protecting biodiversity and enhancing long-term resilience in our green spaces. By endorsing this measure tonight, City Council is affirming the corporate principle that Allentown's Environmental Stewardship should be grounded in science, guided by responsible management and aligned with a long-term well being of residents and ecosystems alike. This Resolution reflects the EAC purpose to protect, reserve our natural resources, reduce environmental risks and ensure continued health and beauty of our public lands.
