Introduced by the Administration on July 23, 2025

Authorization for a change order in the amount of \$5,500.00 with Pennoni Associates, Inc. to obtain the services of an Engineering Firm to perform structural evaluations for Emergency and non-Emergency call outs as needed to make structural assessments and evaluations on commercial and residential properties in the City of Allentown. The original contract was for the estimated budgeted sum of \$25,000.00 per contract year, the addition would bring the contract to a new total of \$30,500.00.

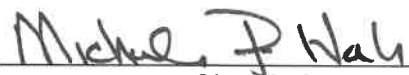

2. Project or Contract Reference: Munis Contract 81 – RFP 2024-28 Emergency & Standard Engineering Services
3. Description of Service(s): To perform structural evaluations for Emergency and non-Emergency call outs as needed to make structural assessments and evaluations on commercial and residential properties in the City of Allentown.

Pursuant to City Ordinances, Article 130.16, this Recommendation of Award is before City Council for its approval of the contract consideration increase.

- This recommendation is for a contract consideration increase of 10% or more for an existing contractual sum. Said contract was previously bid and awarded under city policies.

- Description of project or scope of services to be provided and why is an increase needed:

On December 12, 2024, both parties mutually agreed and entered into an agreement that the contractor shall perform structural evaluations for Emergency and Non-Emergency call outs, as needed, to make structural assessments and evaluations on commercial and residential properties in and for the City of Allentown. At this time, the Parks Department wants to utilize this contract for the consultant to complete a structural analysis of the Golf Course Maintenance Barn (office area), to determine the condition of the building as the current silo is falling apart.

- List the current Contract Term and if an increase is needed:

Term commenced on December 12, 2024, and shall cease one (1) year thereafter on December 11, 2025.

- List any renewal term options and duration of each renewal, if any:

Upon written agreement, this contract may be extended for up to an additional two (2) additional one (1) year terms.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

Estimated budgeted sum of \$25,000.00 per contract year totaling \$80,500.00 with the increase.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved.
