WHEREAS, the City of Allentown is desirous of submitting a formal application to the Pennsylvania Department of Community & Economic Development for a grant of One Hundred Eighty Two Thousand (\$182,000).

NOW, THEREFORE, BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests an Economic Development and Community Development Initiatives grant on behalf of the Allentown Police Department to fund renovations which will provide necessary upgrades to the Police Academy Building.
