

**CITY OF ALLENTOWN**  
**ACCOUNTS PAYABLE WEEKLY CHECK REVIEW**

**For the Check Period end date: 07/05/25 – 08/01/2025**

**Date of Report: August 26, 2025**

**OBJECTIVE**

The objective of the weekly Accounts Payable check review is to determine whether the checks issued, and their corresponding documentation comply with the requirements of the policies, guidelines, and procedure outlined in the AIMS and to identify any areas for improvement.

Overpaid Travel & Expense Advances and their corresponding documentation are being reviewed to determine whether they comply with the requirements of the policies, guidelines, and procedure outlined in the AIMS and to identify any areas for improvement.

Effective 12/2020, outstanding invoices in MUNIS over 30 days are being aged and reviewed to determine why they remain unprocessed and to identify any areas for improvement.

**PROCEDURES**

A review of all the checks and wires generated for the period tested including a review of the invoices being paid and their corresponding documentation, approvals, compliance with AIMS and reasonableness of expenditure.

# Of checks and wires reviewed and posted for the period: 514

\$ Amount of the checks reviewed and posted for the period: \$8,147,519.34.

# Of manual checks reviewed and posted for the period: 8

\$ Amount of the checks reviewed and posted for the period: \$53,300.74.

## **FINDINGS AND RESOLUTIONS**

### **1. Open Invoices**

Invoices must be entered in MUNIS, go through the MUNIS approval queue, and finalize in MUNIS for the expense to be posted in the General Ledger. For Invoices “Paid by Check,” the payment is not made until this process is finalized in MUNIS and a check is generated. Once finalized, the expense is automatically posted to the General Ledger.

Although there is no City standard for the invoice approval queue process, the Controller’s Office uses a 3-week measure to flag any Open Invoices.

We reviewed the open invoices as of 08/05/2025 and identified:

- 1 (one) LIQUID FUELS invoice totaling **\$21,458.14** in “OPEN” status since 03/2025.
- 2 (two) COMMUNITY & ECONOMIC DEVELOPMENT (CED) invoices totaling **\$1,113.06** in “OPEN” status since 04/2025.
- 2 (two) PARKS & RECREATION PCard transactions totaling **\$339.39** in “OPEN” status since 03/2025.

#### **Resolution**

- LIQUID FUELS - Per TREASURY this was a troublesome void and replace that happened right when MUNIS went live. Because the converted Eden invoice was attached to a PO that no longer existed in Munis, Tyler Technologies had to manually void the invoice. It is unclear why it appeared on the Open Invoice Report. TREASURY sent a Tyler support ticket to investigate.
- CED – AP had to call Tyler Tech Support. The cash account had been changed on the batch entry screen to the “uniform” General Ledger account. The account number on the batch entry screen should never be changed. This resulted in the invoices being “frozen”.
- PARKS & RECREATION – Per IT, the invoices are appearing on the report because the status is “Approved” and not “Paid”. The information was communicated to Administration for correction.

### **2. Incorrect Expense Account Used**

GARAGE charged part of 2 (two) invoices totaling **\$5,486.49** for labor and parts to AC 50054 – Repairs and Maintenance Supplies. The expense should be charged to AC 50042 – Repairs and Maintenance.

EMS charged part of 1 (one) invoice totaling **\$1,581.00** for Cables to AC 50072 – Equipment. The expense should be charged to AC 50054 – Repairs and Maintenance Supplies.

#### **Resolution**

The Bureaus were advised of the issues and submitted journal entry corrections.

### 3. Untimely Payment of Invoices

Although not all vendors have the same payment terms, the prevailing vendor payment terms is net 30.

Currently, the City does not have a standard for the time frame invoices must be entered in MUNIS, go through the MUNIS approval queue, and finalize for payment.

Although there is no City standard for the invoice payment process, the Controller's Office uses a 60-day measure to flag any potential untimely invoice payments.

Untimely payments may result in:

- Missed discounts,
- Vendor imposed late fees,
- Possibility of the City's account being placed on hold, and
- Additional workload with the vendor's Accounts Receivable and the City's AP departments.

We identified:

- 8 (eight) checks for 13 (thirteen) GARAGE invoices dated 02/2025, 03/2025, 04/2025, and 05/2025,
- 1 (one) check for 1 (one) HUMAN RESOURCE (HR) invoice dated 03/2025,
- 1 (one) check for 1 (one) IT invoice dated 03/2025,
- 2 (two) checks for 2 (two) POLICE invoice dated 03/2025 and 04/2025,
- 1 (one) check for 1 (one) SPECIAL EVENTS invoice dated 04/2025,
- 1 (one) check for 1 (one) GOLF invoice dated 04/2025,
- 1 (one) check for 1 (one) PARKS invoice dated 04/2025,
- 2 (two) checks for 2 (two) RECYCLING & SOLID WASTE invoices dated 04/2025 and 05/2025,
- 1 (one) check for 1 (one) STREETS invoice dated 05/2025,
- 2 (two) checks for 3 (three) FIRE invoice dated 05/2025 and 06/2025,

#### Resolution

All Bureaus were advised of the issues and the checks were released.

#### GARAGE –

- 01/2025 Invoice: GARAGE was waiting on a sole source to pay for this invoice.
- 02/2025 Invoice: GARAGE was waiting for a budget transfer. GARAGE originally did not have enough money on their PO before the switch to Munis, and when they finally did make the switch they didn't have enough money to create a blanket for work, so they had to wait for a transfer to go through

- 02/2025, 03/2025 and 04/2025 Invoices: GARAGE was unsure if they could do a change order for this vendor for more than \$4,000 since there was no sole source, contract, etc.
- 03/2025 Invoice: GARAGE was waiting on a sole source to be able to submit this for payment, however another department was responsible for entering and receiving this requisition and they never did (receiving).
- 03/2025 and 04/2025: Although numerous requests were made, no response was received.
- 04/2025 Invoice: Typically the vendor is paid with a PCard. GARAGE was unable to get ahold of the vendor to pay for the invoice. When the vendor was reached, GARAGE was informed they would be charged \$150 to process a PCard transaction, so they submitted the invoice to get paid via check.
- 04/2025 Invoice: AP didn't realize that the departments had been told to use the invoice date when they entered the item in receiving. AP had only pulled the "current weeks" dates.
- 05/2025 Invoice: GARAGE was waiting for a budget transfer for the sublet account as they were very low on funds.

HR – HR was unaware of the invoice; the invoice was received by HR on 07/04/2025 holiday.

IT - IT was not able to get this entered right away because of the Eden/Munis upgrade. This contract took me a while to figure out the amounts to enter for each of the 26 accounts. The Contract also took time in the contract approval process since 26 people had to approval each of their accounts. We adjusted the amounts, so the contract had to be put through the full workflow process again. After the invoice was entered into Munis, approval workflow took time because some of the 26 approvers were out on vacation. The invoice was rejected because some approvers did not know what it was for as they did not have to approve each invoice in Eden. Once rejected it had to go through the full workflow process again. It takes time for 26 people to approve each invoice.

POLICE –

- 03/2025 Invoice: The contract required City Council approval. The contract was approved on 06/18/2025.
- 04/2025 Invoice: The invoice was misplaced.

SPECIAL EVENTS – Payment was held until the contract was executed.

- 03/2025 Invoice: HR was unaware of the invoice; the invoice was received by HR on 07/04/2025 holiday.

GOLF - AP received the invoice on 06/30/2025. A change order was required.

PARKS - AP never received an invoice and after waiting for a reasonable amount of time, they called and requested the invoice.

RECYCLING & SOLID WASTE –

- 04/2025 Invoice: The vendor forwarded multiple invoices to AP on 07/24/2025.
- 05/2025 Invoice: Vendor emailed invoice to AP, but the email did not include the required documentation.

STREETS - The invoice "slipped through the cracks".

FIRE –

- 05/2025 Invoice: There were issues with some of the items that did not get resolved until later in June.

- 05/2025 & 06/2025 Invoices: FIRE was unaware of outstanding invoices until notified by vendor on 07/14/2025.

#### **4. Documentation Not Attached in MUNIS**

To provide a proper audit trail and document the expenditure, the hard copy of the invoice and all pertinent payment information is scanned and attached in MUNIS.

For the period 07/05/2025 – 08/01/2025, the following departments did not have the proper documentation attached in MUNIS:

- GARAGE - 3 (three) instances,
- FIRE - 1 (one) instance,
- REVENUE & AUDIT - 1 (one) instance, and
- ENGINEERING - 1 (one) instance.

#### **Resolution**

The Bureaus were advised of the issues, and the proper documentation was scanned.
