**Authorization for Contract with Mohawk Contracting & Development LLC in the amount of \$2,735,000.00 per contract year to construct a new pool facility including utility services, new admissions and restroom support buildings, pool (including pumps, filters, spray features), pool deck (including drainage), artificial turf sitting areas, perimeter fencing, site lighting and other Work indicated in the Contract Documents. The contract shall commence upon full execution and shall cease one (1) year thereafter. Upon mutual agreement and written notification, this contract can be extended for up to an additional four (4) one (1) year terms beyond the contract expiration period.**

On November 8, 2022, the City advertised a solicitation for Irving Pool – Andre Reed Park Development, the intent of this bid is to secure a contractor for construction of a new pool facility including utility services, new admissions and restroom support buildings, pool (including pumps, filters, spray features), pool deck (including drainage), artificial turf sitting areas, perimeter fencing, site lighting and other Work indicated in the Contract Documents. The contract shall commence upon full execution and shall cease one (1) year thereafter. Upon mutual agreement and written notification, this contract can be extended for up to an additional four (4) one (1) year terms beyond the contract expiration period. On December 19, 2022, there was a public opening held, three (3) bids were received. Upon review of said bids, it was determined that Mohawk Contracting & Design was the lowest bid and therefore at this time the City is recommending award to Mohawk Contracting & Design.
