Authorization for Contract with Alloy5, LLC, a small business, in the amount of \$50,000.00 to provide professional services to facilitate the relocation of the City's Fire Department and EMS from Central Fire Station to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Fire Department, EMS and possibly the Health Department to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). Lastly, alternative proposal services include the conceptual design of the needed improvements upon authorization by the City after a decision has been made as a result of the initial services.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Ally5, LLC
2. Project or Contract Reference: RFP No. 2023-33 Feasibility Study for Central Fire
3. Description of Service(s): To provide professional services to facilitate the relocation of the City's Fire Department and EMS from Central Fire Station to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Fire Department, EMS and possibly the Health Department to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). - Description of project or scope of services to be provided:

On August 2, 2023, The City advertised a solicitation for a qualified team to provide professional services to facilitate the relocation of the City's Fire Department and EMS from Central Fire Station to a centralized location. Services are expected to aid the City in determining the space and facility needs for the Fire Department, EMS and possibly the Health Department to operate efficiently out of a modern facility. Additionally, preliminary design services are required to aid the City's decision on where said facility could be constructed and the scope of construction activities (renovation, new construction, a combination). Lastly, alternative proposal services include the conceptual design of the needed improvements upon authorization by the City after a decision has been made as a result of the initial services. On August 30, 2023 the public opening was held for which the City received eight (8) proposals, which were distributed to all committee members via Teams for evaluation. The technical evaluation was held on September 20, 2023, all committee members were present via Teams and in person. The proposal were scored based on the following: IBE Preference (10 Points), Scope of Work (40 Points), Statement of Qualifications (30 Points), and References and Other Information (10 Points). Cost proposals were opened on September 20, 2023, proposals were distributed to all committee members via Teams for evaluation after the completion of the technical evaluation. The cost evaluation was held on September 25, 2023, all committee members were present via Teams and in person. The committee members discussed the cost proposal (20 points). The committee made the recommendation to proceed with oral interviews (15 points). The oral interview meetings occurred on October 18, 2023. Alloy5, LLC presented at 8:30am, MKSD, LLC presented at 9:30am, and Manns Woodward Studios, Inc. presented at 10:30am, all scoring members were present. An evaluation committee completed both technical and cost evaluations on the proposals and an oral interview. The committee decided to award based on the firm's qualifications and overall score. The committee is recommending award to Alloy5, LLC.

- Contract Term:

The contract term shall commence upon full execution and shall cease one (1) year thereafter.
