- Becky what can be done about the poison hemlock that is spreading in many of the riparian buffers and beyond in the parks? Unfortunately, it spreads quickly. City sprays twice a year. Sometimes the cure isn't better than the situation we have. So, the question becomes, is the removal worse than keeping it?
