## Introduced by the Administration on October 15, 2025

Authorization Engagement of Professional Services with Michael Baker International in the amount of \$72,708.00 for the addition of an NPDES permit, post construction stormwater management (PCSM) plans to the design of the MLK Trail Phase 1 project at the direction of DEP/Lehigh County Conservation District. This scope also includes revisions to the Erosion and Sediment Control Plan, bid specification documents, and the cost estimate to add the PCSM items to the project.

## Resolved by the Council of the City of Allentown, That

**WHEREAS,** Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS,** it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

- 1. Name of Contractor/Consultant: Michael Baker International
- 2. Project or Contract Reference: VAV Renovation, Contract No. 707
- 3. Description of Service(s): To add a number of tasks to the design of the MLK Trail Phase 1. Those tasks include preparation of an NPDES permit and post construction stormwater management (PCSM) plans at the direction of DEP/Lehigh County Conservation District. This scope also included responses to land development review comments, revisions to the Erosion and Sediment Control Plan to add PCSM improvements, revisions to the bid specification documents and the cost estimate to add the PCSM items to the project and adjustments to the cost estimate for inflation due to a revised construction schedule.
