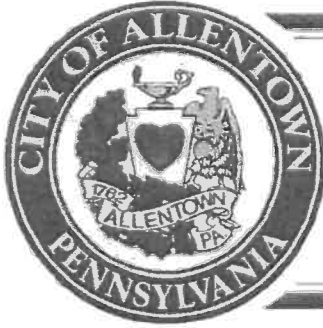

Wilt served on the Board for a number of years as an Allentown School Board member, and would now like to serve as a resident. She will be replacing Joan Nyemscek; her resume is attached.

Bio for Nancy Wilt

Nancy Wilt has spent the past 35 years working as an organizer, advocate and both a government staffer and elected official. She began her career as a community organizer for the Allentown office of Clean Water Action, working in both organizing and management positions. In 1995, she started working as the Executive Legislative Assistant to then Representative Lisa Boscola, where she stayed for 18 years before being hired as Chief of Staff to State Representative Peter Schweyer in 2014, for whom she currently works.

Nancy has been an active member of her community, serving on Parent-Teacher Executive Boards at Union Terrace Elementary, Raub MS and William Allen HS, as well as the Superintendent Advisory Board for Allentown School District while her children were students.

She has served on the Allentown School District Foundation Board, where she held the position of Secretary, The Coalition for Appropriate Transportation, The Century Promise Board, and various steering committees for both the United Way and Community Action Lehigh Valley.

Nancy was elected to serve as a member of the Board of Directors for the Allentown School District in December of 2019, where she served two years as President and one year as Vice-President. She represented the school board as a member of the Allentown Public Library Board, and the Allentown Parks and Recreation Board.

Nancy continues her work on public education through her work with Representative Schweyer, who is presently Majority Chairman of the Education Committee for the Pennsylvania House of Representatives. And, will continue to serve on the Allentown Parks and Recreation Board as a resident of the city.

Nancy served as a past officer for the Allentown City Democratic Committee and has been a long-time PCP for the Lehigh Democratic Party. She has worked to elect numerous democratic candidates over the past 35 years.

Nancy has three adult children and lives with her husband Scott in Allentown.
