AN ORDINANCE

Amending the 2025 Capital Fund Budget to provide for an increase of One million Nine Hundred Thousand Dollars (\$1,900,000.00) to a newly created Capital Account to enhance road safety and improve pedestrian and cyclist accessibility on South Jefferson Street. These upgrades will enhance safety and infrastructure for vulnerable road users along this corridor. The City was awarded an ARLE grant, and these funds are fully reimbursable.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes an increase in the amount of One million Nine Hundred Thousand Dollars (\$1,900,000.00) as follows:

Public Works Department

- Summary and facts of the bill.

The City applied for and was awarded a \$1,900,000 ARLE Grant that will fund a comprehensive redesign of South Jefferson Street (a 50-foot-wide roadway), to enhance road safety, improve pedestrian and cyclist accessibility, and promote efficient transit operations.

 - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

This bill will allocate the funding for the design, inspection, and construction of South Jefferson Street to enhance the safety and infrastructure for vulnerable road users.

- b. What are the benefits of doing this? What are the drawbacks?

The redesign of S. Jefferson Street is critically necessary due to existing safety concerns and inadequate infrastructure for non-motorized road users. High vehicle speeds, increasing accident rates, insufficient pedestrian and cyclist facilities, and numerous resident complaints and speeding and unsafe conditions have created a pressing need for comprehensive improvements. There are no drawbacks.

- c. How does this bill relate to the City's vision/mission/priorities?

The project aligns with broader community and development goals, seeking to provide a safer, more accessible environment for all road users and to support efficient public transit.

This grant is fully reimbursable and will cover \$1,900,000 of the project. Any additional funding commitments are the responsibility of the City of Allentown, Public Works Department.
