AN ORDINANCE

Amending the 2025 General Fund Budget to provide for a supplemental appropriation of One Hundred Thirty-Two Thousand Eight Hundred Dollars (\$132,800.00) from the Pennsylvania Commission on Crime and Delinquency (PCCD) Grant to the City of Allentown Police Department. These funds will be utilized for reimbursement of expenses for the purchase of case management software, mobile devices, program analysis, unit apparel and additional Community Intervention Specialist.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation of One Hundred Thirty-Two Thousand Eight Hundred Dollars (\$132,800.00) to the following account:

Purpose of the ordinance is to amend the 2025 General Fund Budget to provide a supplemental appropriation of One hundred thirty-two thousand, eight hundred \$ 132,800 from the Pennsylvania Commission on Crime and Delinquency (PCCD) Grant to the City of Allentown Police Department to utilize the funding for reimbursement of expenses for the purchase of case management software, mobile devices, program analysis, unit apparel and additional Community Intervention Specialist.

 - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

This is an allocation of \$ 249,200 by Pennsylvania Commission on Crime and Delinquency (PCCD) Local Law Enforcement Grant Program. This budget is broken into a two-year period allowing for \$ 132,800 to be utilized in 2025 and the remainder budgeted of \$ 116,400 for 2026. The funding will allow for reimbursement of expenses for the purchase of case management software, mobile devices, program analysis, unit apparel and additional Community Intervention Specialist

- b. What are the benefits of doing this? What are the drawbacks?

The benefits of this funding will allow us to hire an additional mental health worker which is paramount to the successful implementation of this program. This funding will also allow for Crisis Intervention Specialist to ride and assist the police on a regular basis.

- c. How does this bill relate to the City's vision/mission/priorities?

This program will ultimately reduce the amount of repeated emergency calls and will allow for Crisis Intervention Specialist to apply needed resources to those who are in need of assistance.

The grant for 2025 year is in the amount of \$ 132,800 based on expected expenses for purchasing the case management software, mobile devices, program analysis, unit apparel and additional Community Intervention Specialist
