#### AN ORDINANCE

Amending the 2023 Fire Department budget to provide for a supplemental appropriation of Thirty-Nine Thousand Seventy-Three Dollars and Sixty-Three Cents (\$39,073.63) from the Department of Homeland Security grant for the purchase of Wellness and Fitness equipment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2023 General Fund in the amount of Thirty-Nine Thousand Seventy-Three Dollars and Sixty-Three Cents (\$39,073.63) reflecting receipt of monies from the Department of Homeland Security grant for the purchase of equipment.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Fire Department budget as follows:

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

• What department or bureau is this bill originating from? Where did the initiative for the bill originate?

The bill originated from the Allentown Fire Department. The Allentown Fire Department was awarded a Department of Homeland Security grant to purchase Wellness and Fitness Equipment.

• Summary and facts of the bill.

The Bill will provide funding for the purchase of Wellness and Fitness equipment. This funding will bring the Allentown Fire Department in compliance with NFPA 1983 standards for Health-related fitness programs for firefighters. It establishes the minimum requirements for a health-related fitness program for fire department members who are involved in rescue, fire suppression, first-responders, hazardous materials operations, special operations and related activities.

In order to be fit for duty, firefighters have to be physically and psychologically prepared to endure the demands of this profession. This standard requires fire departments to establish a "health-related fitness program that enables members to develop and maintain a level of health and fitness to safely perform their assigned functions".

The Bill will provide funding for the purchase of Wellness and Fitness equipment. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.

The cost is 90% grant funded and 10% city shared budgeted expense.
