AN ORDINANCE

Amending the 2025 Fire Department budget to provide for a supplemental appropriation of Two Hundred Thousand Three Hundred Seventy-Five Dollars (\$200,375.00) from the County of Lehigh grant. These funds will be used to update and repair the Fire Academy Training Tower.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 General Fund in the amount of Two Hundred Thousand Three Hundred Seventy-Five Dollars (\$200,375.00).

This bill originates from the Fire Department.

The Allentown Fire Department was awarded a County of Lehigh Grant for a project to update and repair the Fire Academy Training Tower.

The Fire Training Tower, located at 1902 Lehigh Street within the Allentown–Mack South Training Grounds, has been a critical resource for our first responder community in Lehigh County for over 50 years. To maintain the safety and effectiveness of this facility, essential repairs and upgrades are necessary. This proposal outlines plans to modernize the tower's infrastructure and replace the current Row Home Simulator with a Concrete Masonry Unit (CMU). The unit is used for Rapid Intervention Training for Fire Fighter Down, Confined Space, Search Simulator, etc. This ensures the training center can meet the demands of our first responders and support regional collaboration.
