## AN ORDINANCE

Amending the 2023 General Fund Budget to provide for a supplemental appropriation of Fifty Thousand (\$50,000.00) Dollars from the United States Conference of Mayors and the American Beverage Foundation for a Healthy America (ABFHA) grant to the Mayor's office Civic Innovations Fund for a hybrid program in Allentown targeted towards childhood obesity prevention, environmental health and sustainability.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2023 General Fund in the amount of Fifty Thousand (\$50,000.00) Dollars reflecting receipt of monies from the United States Conference of Mayors and the American Beverage Foundation for a Healthy America (ABFHA) grant.
