AN ORDINANCE

Amending the 2025 General Fund Budget to provide for a supplemental appropriation of Five Thousand (\$5,000.00) Dollars from Pool & Hot Tub Foundation under the Step Into Swim grant program to support swim lessons at city pools.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 General Fund in the amount of Four Thousand (\$5,000.00) Dollars from Pool & Hot Tub Foundation as follows:
