Authorizes the submission of the formal application to the Pennsylvania Office of the Budget for a grant in the amount of Five Hundred Thousand (\$500,000.00) Dollars to support the renovation of the Scottish Rite Cathedral.

Resolved by the Council of the City of Allentown, That


BE IT RESOLVED, that the City of Allentown, Lehigh County and ASSR Lehigh Consistory hereby requested a Redevelopment Assistance Capital Program grant for \$500,000.00 from the Pennsylvania Office of the Budget to fund the renovation of Scottish Rite Cathedral on 1533 Hamilton Street Allentown, PA 18102.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matthew Tuerk Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit and accept Five Hundred Thousand (\$500,000.00) Dollars in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.
