Introduced by the Administration on April 5, 2023

Approves the submission of an application for a grant from the Commonwealth of Pennsylvania Department of Conservation and Natural Resources for the continued development of the Martin Luther King Trail. The City is asking for \$650,000.00 in grant funding with a match required – in-kind or cash.

Resolved by the Council of the City of Allentown, that

WHEREAS, the City of Allentown is desirous of obtaining funds from the Commonwealth of Pennsylvania Department of Conservation and Natural Resources.

NOW, THEREFORE, BE IT RESOLVED, the Park Rehabilitation and Development grant under the Community Conservation Partnership Program will allow funds for the continued development of the Martin Luther King (MLK) trail.

BE IT FURTHER RESOLVED, the City of Allentown Department of Parks and Recreation will assure the provision of other necessary funds to make the activity feasible.

BE IT FURTHER RESOLVED that the Commonwealth of Pennsylvania Department of Conservation and Natural Resources will tentatively fund \$650,000.00.

BE IT FURTHER RESOLVED that the appropriate officer of the City of Allentown is directed to execute a certificate attesting to the adoption of this resolution and to furnish a copy of this resolution to The Commonwealth of Pennsylvania Department of Conservation and Natural Resources.
