***BE IT FURTHER RESOLVED***; that the City of Allentown hereby designates Matthew Tuerk Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

## Legislative Template

Department of Community and Economic Development – Grants Bureau. This bill is originating from the Police Athletic League (PAL).

- Summary and facts of the bill.

The City is submitting a formal application to the Pennsylvania Department of Community and Economic Development for \$400,000 awarded from the Statewide Local Share Account Fund (LSA) that will support the renovation of the Police Athletic League building.
