AN ORDINANCE

Amending the 2024 Fire Department budget to provide for a supplemental appropriation of Ten Thousand Dollars (\$10,000) as a result of The Hartford grant for the purchase of a fire extinguisher simulator.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2024 General Fund in the amount of Ten Thousand Dollars (\$10,000.00).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Fire Department budget as follows:

SECTION THREE: That this Ordinance takes effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

• What department or bureau is this bill originating from?

The bill originated from the Allentown Fire Department. The Allentown Fire Department was awarded a grant from The Hartford to purchase a fire extinguisher simulator.

• Summary and facts of the bill.

Earlier this year, The Hartford published its third Home Fire Index, ranking the top 150 cities with the highest home fire risk. Allentown was ranked #136. Because of this, the Allentown Fire department was awarded a \$10,000 grant from The Hartford to be used towards fire safety education. With this grant, the Prevention office would like to use it to purchase a fire extinguisher simulator.

This bill will utilize a received grant to purchase a fire extinguisher simulator.

With the majority of home fires being caused by careless cooking, having a simulator will be beneficial in teaching families the importance of having an extinguisher in a home and more importantly how to use it.

Our current model is several years old, cumbersome to transport, and can only be used outdoors/weather dependent. The new simulator is state of the art technology, and the software gets lifetime updates for programming. Its purpose is to train the public; when they are trained on it, it can be a tool to save lives and property.
