#### AN ORDINANCE

Amending the 2024 Community and Economic Development, Health budget to provide for a supplemental appropriation of One Hundred Ten Thousand Dollars (\$110,000.00) from the Pennsylvania Department of Health grant for the expansion and use of ESRI and GIS software.

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2024 General Fund in the amount of One Hundred Ten Thousand Dollars (\$110,000.00).

The Allentown Health Bureau has received a grant from PADOH- ELC & Enhancing Detection for the purpose of expanding public health use of ESRI and GIS. This will place the Allentown Health Bureau in line with the other municipal health departments in the state concerning access and use of ESRI and GIS software.
