One (1) bid was received, contract shall be commence upon full execution and cease December 31, 2025, with two (2) additional one (1) year renewals beyond that contract expiration period.

**WHEREAS**, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

On October 25, 2024, the City advertised to secure the services of a qualified Vendor to furnish and supply various industrial gases for various departments within the City of Allentown. On November 20, 2024, there was a public opening held, for which one (1) bid was received. Upon review of the bid, it was determined to recommend award to Linde Gas & Equipment Inc.

- Contract Term:

The contract term shall be upon full execution and shall cease December 31, 2025.

Upon written notification, this contract can be extended for two (2) additional one (1) year terms beyond the contract expiration period.

Estimated yearly sum of \$45,000.00 totaling and estimated total sum of \$135,000.00 if all renewals are utilized.
