AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a transfer of Fifty-Four Thousand (\$54,000.00) Dollars from the Street Lighting Upgrade (2008) capital accounts to a newly created capital account to cover the match funds needed for a grant. The match funds will cover the purchase of upgraded lighting for this project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of Fifty-Four Thousand (\$54,000.00) Dollars as follows:

Department of Public Works – Traffic Planning & Control

The Bureau of Traffic has applied and been awarded a MTF-DCED grant for a total of \$350,000 of which \$54,000 is for City match. The project is to support installation of new streetlights along Martin Luther King Jr Dr. from the 8th Street Bridge overpass to Union St.
