AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a transfer of funds within the Skatepark Development (1682) capital project in the amount of Twenty-One Thousand Three Hundred and Fifty-One Dollars and Seventy-Two Cents (\$21,351.72). The purpose of this transfer is to purchase new lighting to be installed by the Parks and Recreation Department.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of Twenty-One Thousand Three Hundred and Fifty-One Dollars and Seventy-Two Cents (\$21,351.72) as follows:

Parks and Recreation.

The Department would like to transfer \$21,351.72 Skatepark Development project (1682) to install new lighting for the Jordan Skatepark.

Parks and Recreation is requesting a transfer within the Skatepark Development (1682) capital project in the amount of \$21,351.72. The purpose of this transfer is to purchase new lighting to be installed by the Parks and Recreation Department. The funds were allocated for this purpose. The funds need to be moved to the proper expenditure account.
