The following documents were introduced: Disposition of the City of Allentown to the Application for Heart and Lung Benefits, Heart Center of Philadelphia report, Cardiothoracic Surgery Services report, James Alpha request for disability pension effective 3/31/23, James Alpha request for pension calculation, Paid Firemen's Pension Fund ordinance Article 145, Paid Firemen's Pension Fund ordinance Chapter 75 (new codification), IAFF solicitor opinion on service vs. non service related disability pension calculation, Humes' pension calculation, letters from Drs. Cruz, Page, and Bognet regarding Mr. Apha's condition.

Mr. Warmkessel stated that the reports show Mr. Alpha will not improve enough to return to work.

The Board had no questions for Mr. Alpha or Mr. Warmkessel.

Chief Agosto moved that the Board choose Dr. Louis Samuels and Dr. Steven J. Nierenberg as medical examiners for this case per section 145.20 (75-101). Mr. Stribula seconded the motion. All present voted in favor and the motion passed.

Mr. Bruce moved that Mr. Alpha be given a service related disability pension effective March 31, 2023 in the amount of \$45,385.56 annually (\$1,745.60 bi-weekly). Ms. Patel seconded the motion. All present voted in favor and the motion passed.
